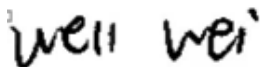

3.1.2 EUT RF Exposure Evaluation

Minimum distance between antenna to body: 5[mm]

Maximum output power including tolerance: 3 [dBm]

Maximum Antenna Gain: 1.72 [dBi]

Worst EIRP = 3[dBm]+1.72[dBi] = 4.72[dBm](2.96mW)

$[2.96 \text{ [mW]} / 5 \text{ [mm]}] * [2.480 \text{ [GHz]} ^ (1/2)] = 0.932 \leq 3.0$

The worst EIRP is enough low compare the exclusion level.
