

- ① Do not use this product if you have had eye surgery.

Wear

The user adjusts the length of the elastic band to the user's favorite position according to the size of the head circumference.

Boot

In the off state, press and hold the key for 2 seconds to start working.

Lithium battery low voltage protection

When the product is low, the voice will be broadcast "The battery is not enough, please charge it in time".

Maintenance

Maintenance

- ①Take measures against moisture, rodents and pollution.

Can not boot	Is the battery low?	If yes, please charge the machine
Massage intensity is too weak	Is the power weak?	If yes, please charge the machine

Product Battery Dismantling Steps

- ① Cut off the external power supply and remove the product shell;
- ② Cut off the two power lines connected to the battery in turn.
- ③ Remove the battery and glue the break of the power cord with insulator glue.
- ④ Disused batteries should be placed at a fixed recycling point.
- ⑤ Please follow the local environmental laws and guidelines to abandon and protect the environment.

Be careful

First, the battery must be removed from the device before it is discarded.

First, before removing the battery, the appliance must be powered off first.
