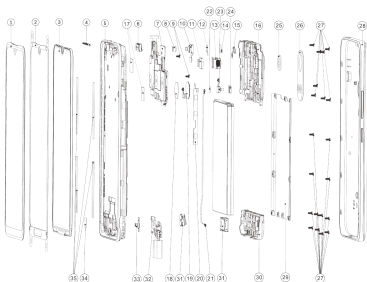

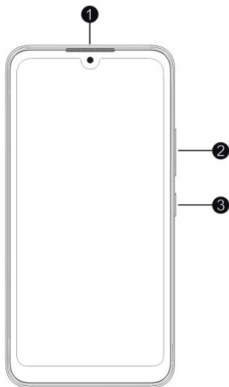

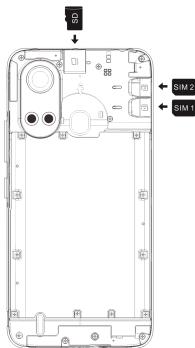
Know your phone

SIM/SD card installation

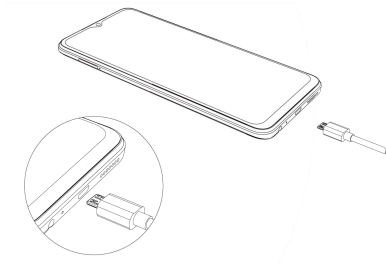
1. Power off mobile.

Charging the phone

You can charge your device using a charger or by connecting it to the computer using a USB cable (comes with the phone).

1. Please remind the front and back of the plug.
2. Use only **VIMOQ** charger and cables. Other chargers or cables may damage the device. This will invalidate your phone warranty.

Note: This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to part 15 of the FCC Rules. This device was tested for typical body-worn operations with the back of the handset kept 10 mm from the body. Body-worn Operation

This device was tested for typical body-worn operations. To comply with RF exposure requirements, a minimum separation distance of 1.0 cm must be maintained between the user's body and the handset, including the antenna. Third-party belt-clips, holsters, and similar accessories used by this device should not contain any metallic components. Body-worn accessories that do not meet these requirements may not comply with RF exposure requirements and should be avoided. Use only the supplied or an approved antenna.
