


# Activate your machine in a few steps

## Specific Absorption Rate (SAR) information:

This device meets the government's requirements for exposure to radio waves. The guidelines are based on standards that were developed by independent scientific organizations through periodic and thorough evaluation of scientific studies. The standards include a substantial safety margin designed to assure the safety of all persons regardless of age or health. ## How to accept payments with QR code and Pix?



Your customer scans the QR code with his cell phone

**i** First, register a Pix key in the Mercado Pago app, in the Your profile section. It is required to receive payments from bank or digital accounts.

**1** Enter the valor of the sale and press "Accept" , then select the option Code QR Pix.

**2** Ask your customer to use the app of any bank or digital account to scan the QR code that will appear on the machine.

**3** The customer completes the payment on his cell phone and that's it!

You can send the voucher to your client via SMS.



## How to accept card payments?



NFC card reader

**1** Enter the amount of the sale and press "Accept" , then choose the payment method.

**2** If paying by credit card, choose the number of installments.

**3** Insert or bring the card close to the machine. If necessary, ask the customer to enter the password. That's it!

#### FCC Regulations
