



The EP20ENC desktop enroller is one of the most powerful multi-tech RFID desktop enrollers in the market, supporting over 20 card types and suitable for any horizontal desktop placement. It can be connected to a PC or other devices via the USB interface (currently only supported on PCs running Windows 7/10/11 OS), and its operation is facilitated by the application of no-driver USB for easy installation.




3 Enroller Connection

EP20ENC enroller can capture the card number in the card induction area and output it via USB to the card number edit field of ARMATURA One software.



Refer to the following steps to enter the card number.

1. Connect the Enroller to the PC via the USB(Type A) interface (currently only supported on PCs running Windows 7/10/11 OS).
2. Log in to the ARMATURA One software.
3. Click **Personnel > Personnel > New** to access the Add User Interface.
4. Move the cursor to the New Window Card Number edit field.
5. Place the card in the Card Reading Area of the reader.
6. The card number can be entered automatically.
7. Then click **OK** to save and exit.
