Nose pads of different sizes are provided. Please choose proper nose pads for comfort


Myopia correction accessory (to be purchased separately)

A magnetic myopia glasses frame and a myopia lens template are provided. Please choose the proper myopia lenses according to the conditions of your eyes (please consult your supplier about myopia lens customization). When installing the lenses. please pay attention to the four positions of the magnetic myopia glasses frame and wear gloves as much as possible to prevent fingerprints on the myopia lenses.

4 Quick guide:

Power on the glasses.

Long press the power button for 2s. If the blue LED is lit, it suggests successful power-on.




Wear the glasses and adjust till a comfortable position.

Move the glasses up, down, leftward or rightward and adjust the nose pad width.

Reminder: If you still feel discomfortable after nose pad adjustment, replace the nose pads,

Operate as instructed on the screen after glasses power-on.

Operate through the right touchpad or the ring as instructed on the screen and connect to the network to activate the product.
