### 3 ENGINEERING STATEMENT

This report has been prepared on behalf of Volk Optical, Inc., to provide documentation for the SAR Exclusion herein. This equipment has been tested and found to comply with the SAR Exclusion levels listed in Appendix A of KDB447498. The minimum distance from the BT module antenna is 5mm. The maximum reported output power of the BT was 6.31mW, which is below the exclusion limit of 10mW at 5mm.

#### Appendix A
