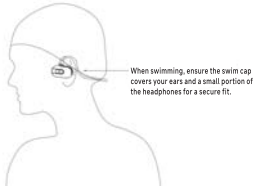

Product Function Diagram

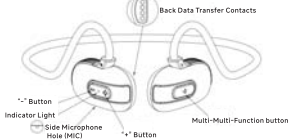


1. How to Wear

For optimal performance, wear the headphones as shown in the diagram.

3. Operating Instructions
Power & Connectivity

- **Power On:** Hold the Multi-Function button for 2 seconds. The blue light will flash for 1 second.
- **Pairing:** When the red and blue lights flash, the headphones are in pairing mode. Select the device on your phone. The blue light will blink every 4-5 seconds once paired. Note: Only one device can be connected at a time.
- **Switching Playback Mode:** Double-tap the Multi-Function button to switch between Bluetooth and local playback.
- **Power Off:** Hold the Multi-Function button for 4 seconds. The red light will flash briefly before shutting off.

- **Volume:** Tap “-” to decrease, and “+” to increase.
- **Track Selection:** Hold “-” for the previous track, hold “+” for the next track.
- **Play/Pause & Calls:** Tap the Multi-Function button to play/pause music or answer/end calls. Hold for 1 second to reject a call.
- **Local Playback Mode:** Triple-tap the Multi-Function button to switch between single-track repeat and all-track repeat.
- **Voice Assistant:** Hold the Multi-Function button for 2 seconds until you hear a beep to activate voice assistant.

4. Charging & Data Transfer



To charge or transfer data:
1.Connect the USB end of the magnetic charging cable to your computer or adapter.
2.Attach the magnetic end to the back contact points of the headphones.
Note: Keep the back contact points and charging base clean to prevent charging failures or data transfer issues.

5. Using the Headphones While Swimming

5.1 Pre-Swimming Preparation

- Switch to MP3 mode before entering the water.
- Wear a well-fitted swim cap.
- Position the headphones correctly: L for the left ear, R for the right ear.
- Tuck part of the headphone wire under the swim cap to keep them secure.

5.2 Safety & Precautions

- Do not disassemble or modify the headphones to avoid damage or hazards.
- Unplug the charger after charging; do not leave it plugged in for over 12 hours.
- Avoid damaging the battery; do not expose it to heat or impact.

- Charging base and cable are not waterproof—keep them dry.
- Do not use in ocean water.
- Bluetooth signals do not work underwater beyond 1 meter—use local playback mode when swimming.
- Follow local swimming pool regulations when using the headphones in public facilities.
- These headphones are suitable for freshwater, pool water, tap water, and sweat—do not expose them to other liquids.
- Avoid high-volume music for long duration to protect hearing.
- After swimming, dry the headphones with a towel and air dry in a ventilated area—do not expose to direct sunlight.
