Band2-1.4MHz-QPSK-18607-1RB#0-Range3:2000~20000MHz



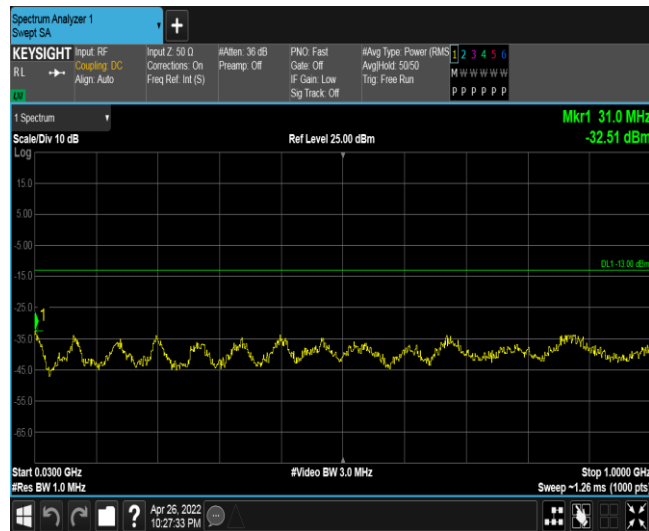

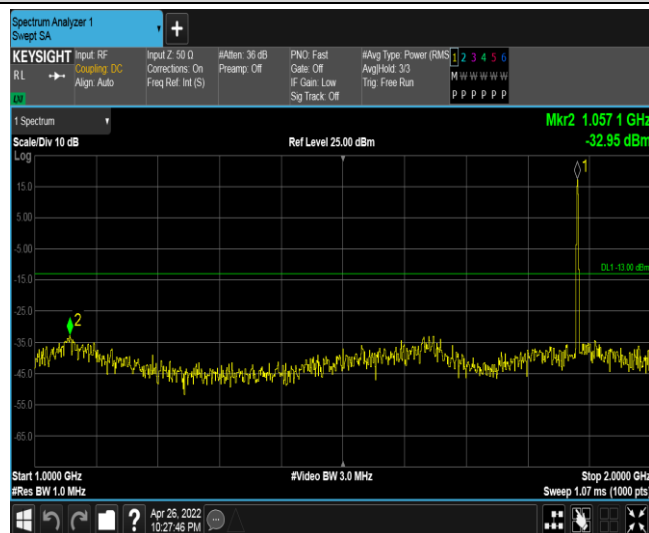
