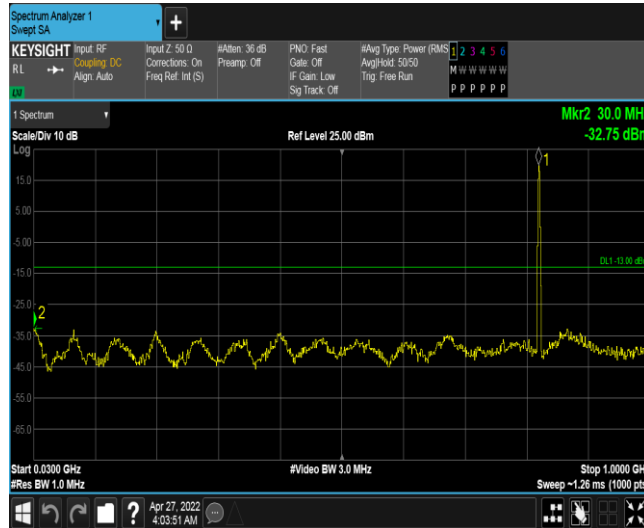

Band5-1.4MHz-QPSK-20407-1RB#0-Range1:30~1000MHz



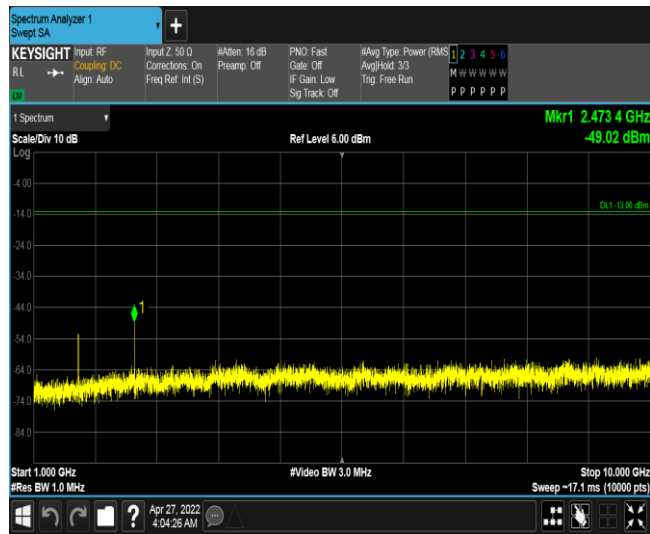

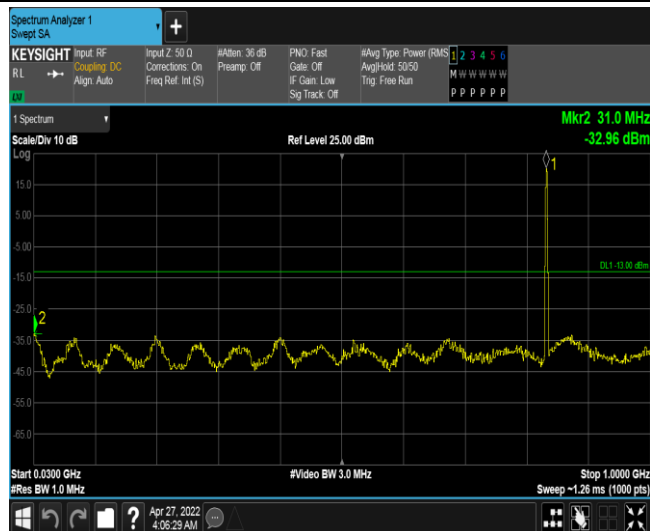
