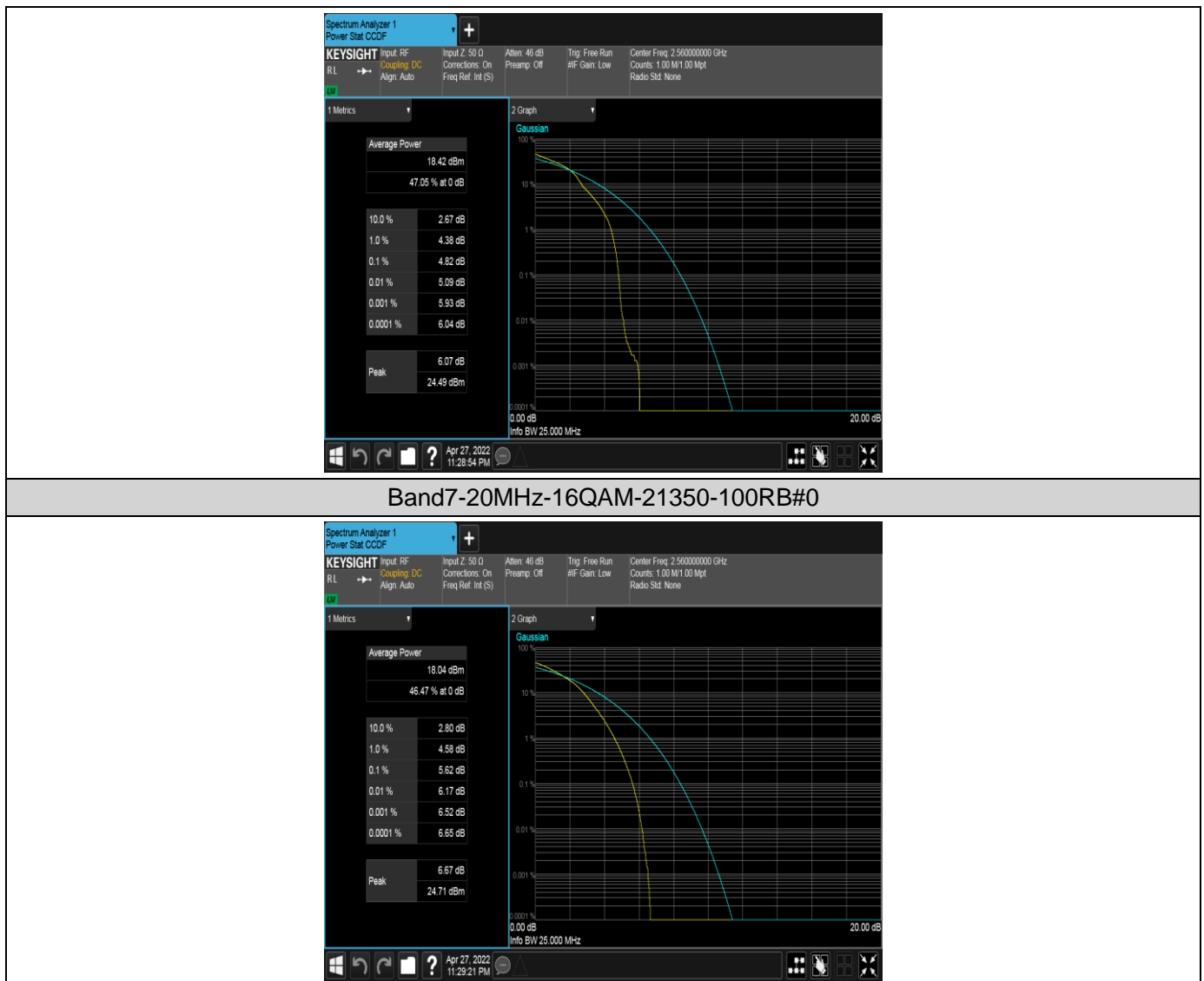


Band7-20MHz-16QAM-21100-100RB#0
