Band7-5MHz-QPSK-20775-1RB#0-Range2:1000~3000MHz



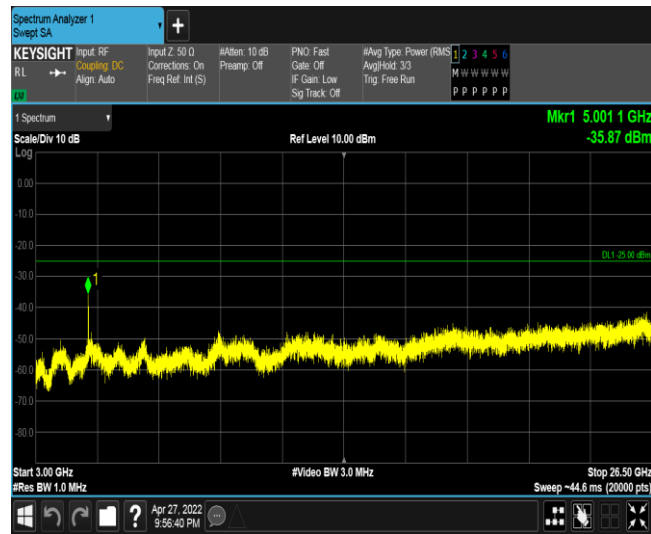
