



Band7-5MHz-QPSK-21100-25RB#0









Band7-5MHz-16QAM-21100-25RB#0







Band7-10MHz-QPSK-20800-50RB#0









Band7-10MHz-16QAM-20800-50RB#0







Band7-10MHz-16QAM-21400-50RB#0









Band7-15MHz-QPSK-21375-75RB#0






