Band38-5MHz-QPSK-37775-1RB#0-Range2:1000~3000MHz



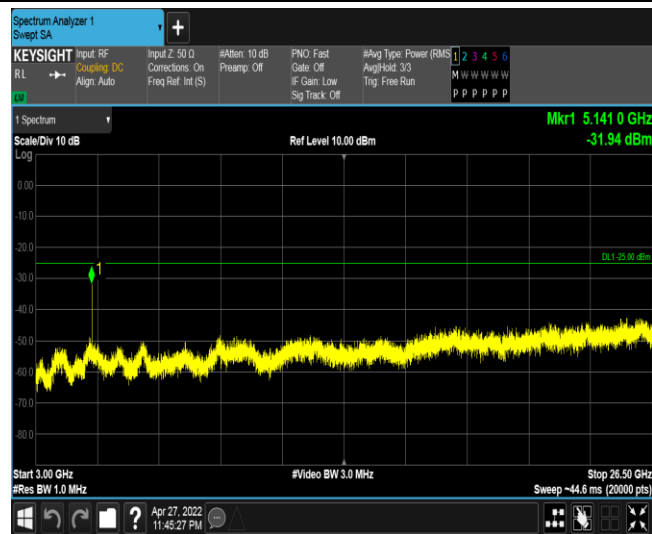
