Band41-10MHz-16QAM-39700-1RB#0-Range3:3000~26500MHz



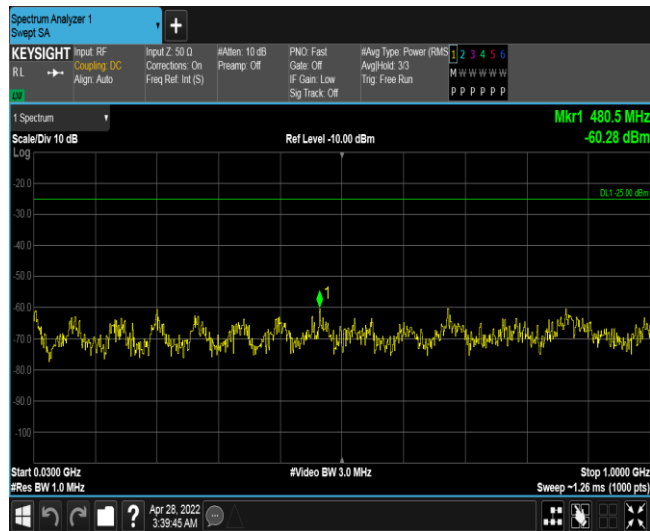
