Band5-5MHz-QPSK-20525-1RB#0-Range2:1000~10000MHz

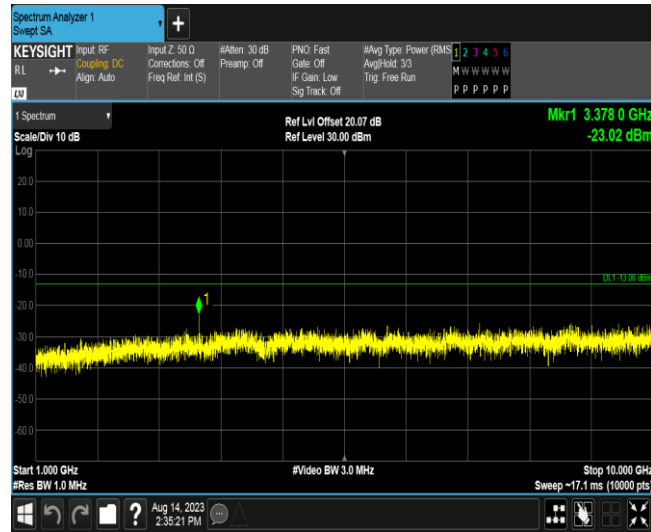


Band5-5MHz-QPSK-20625-1RB#0-Range1:30~1000MHz

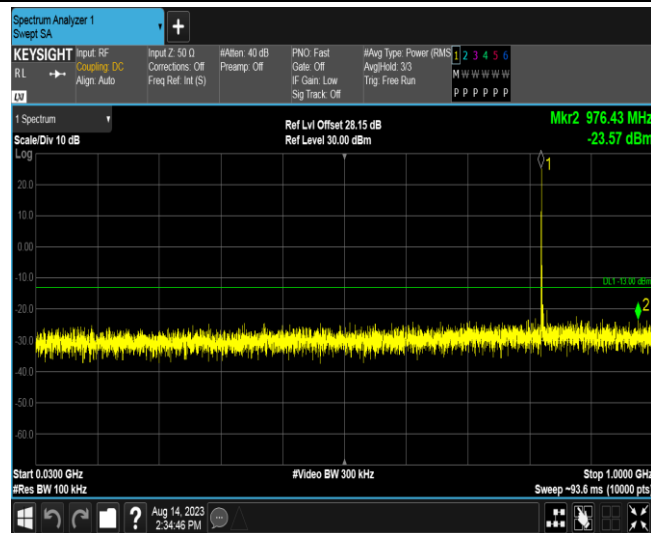

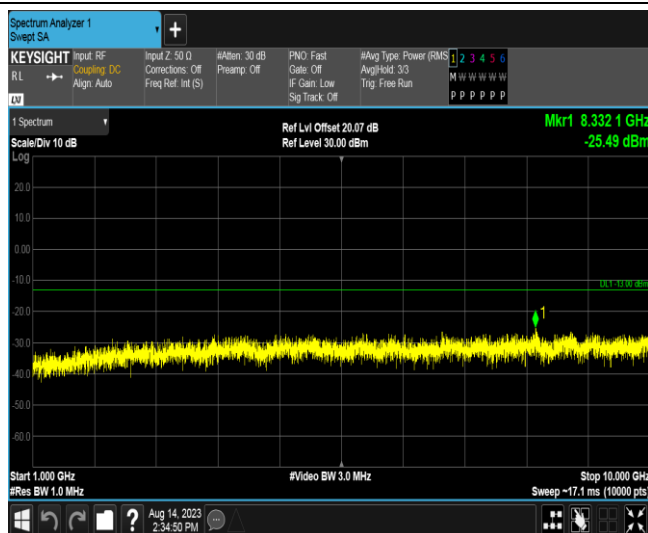

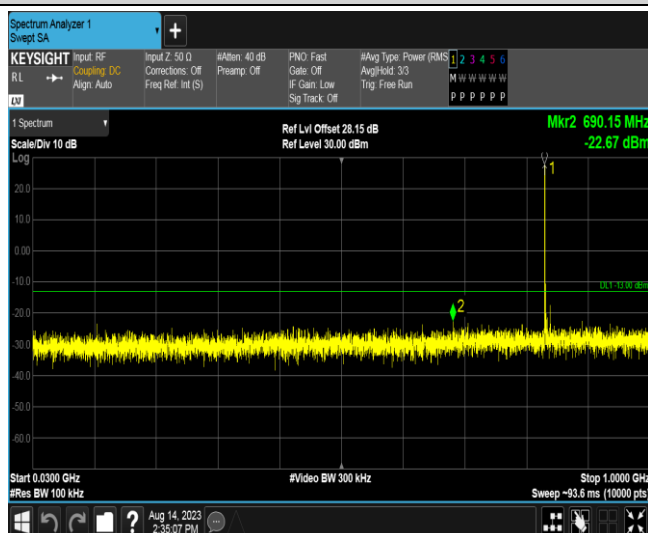

Band5-5MHz-16QAM-20525-1RB#0-Range1:30~1000MHz

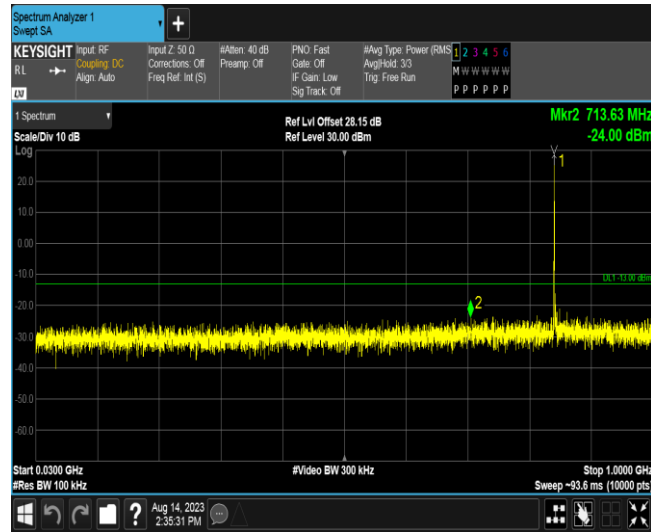


Band5-5MHz-16QAM-20525-1RB#0-Range2:1000~10000MHz

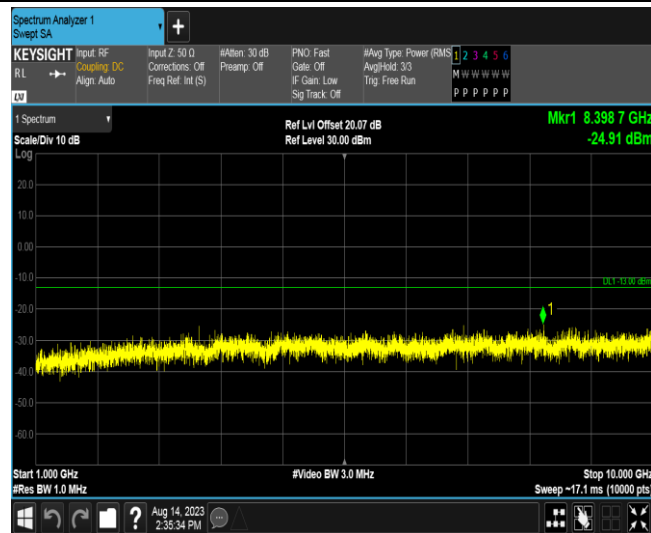
