Band38-15MHz-QPSK-38000-1RB#0-Range2:1000~27000MHz

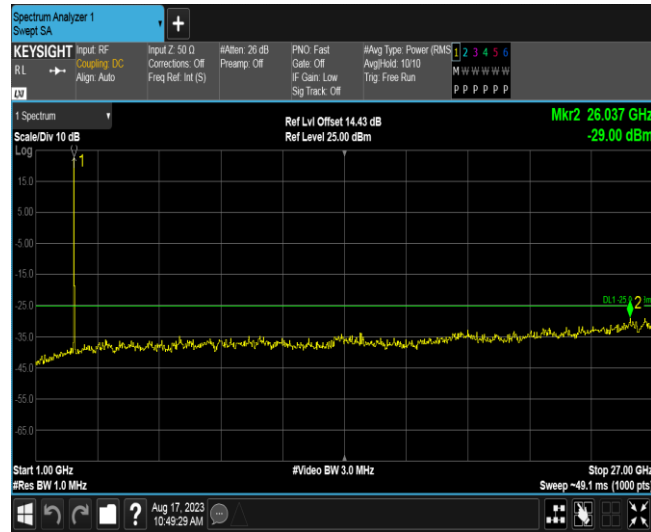

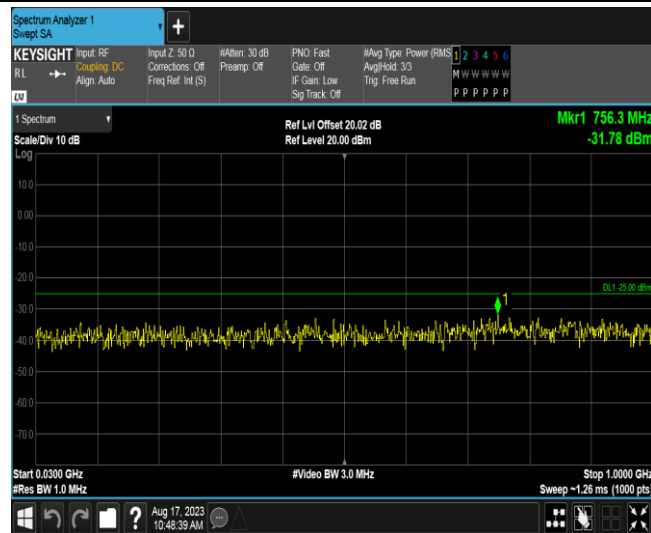
