Band4-1.4MHz-16QAM-20393-1RB#0-Range2:1000~2000MHz

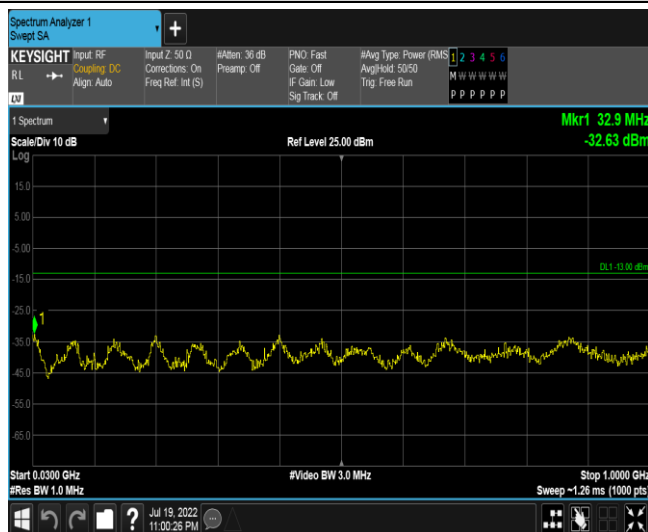

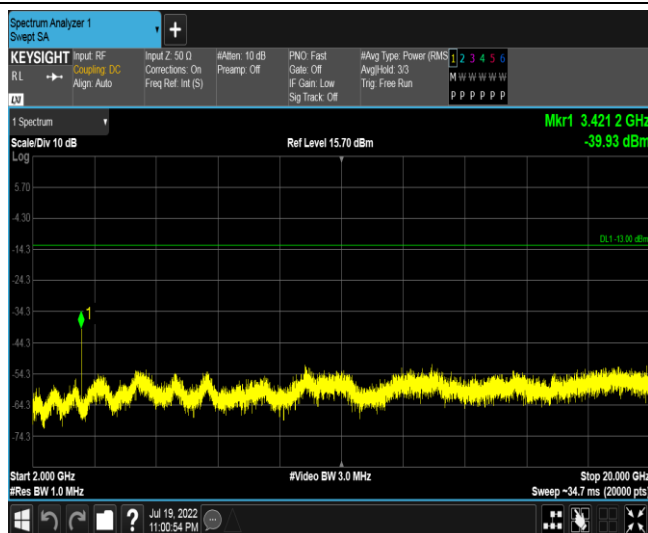
