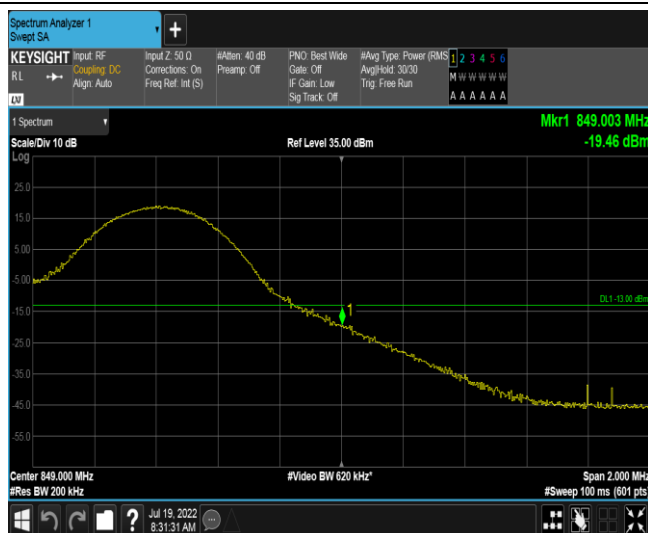


Band5-10MHz-16QAM-20600-1RB#0
