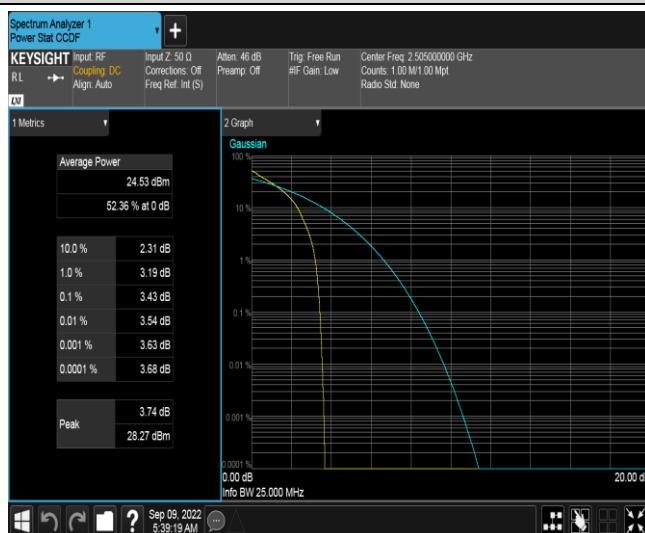

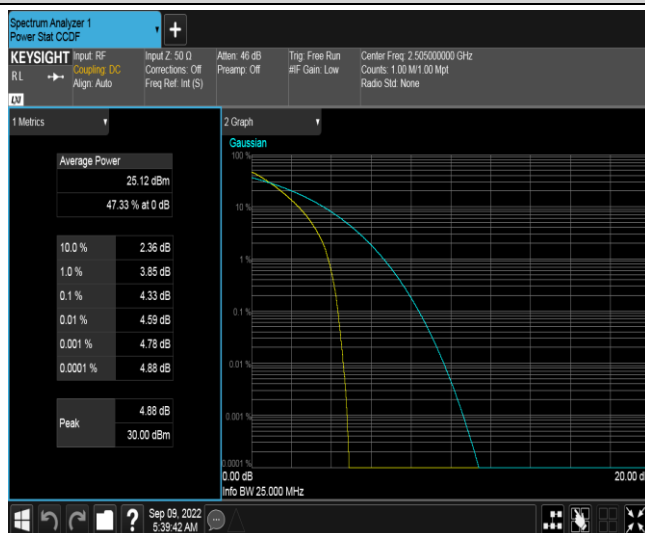

Band7-10MHz-QPSK-20800-50RB#0



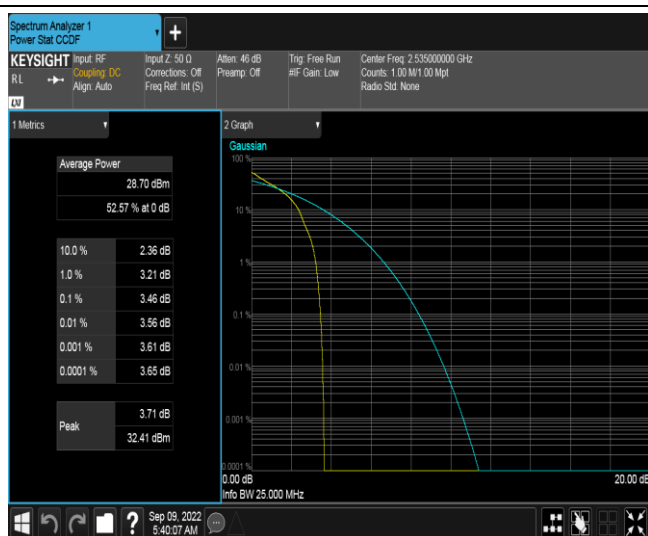

Band7-10MHz-QPSK-21100-50RB#0

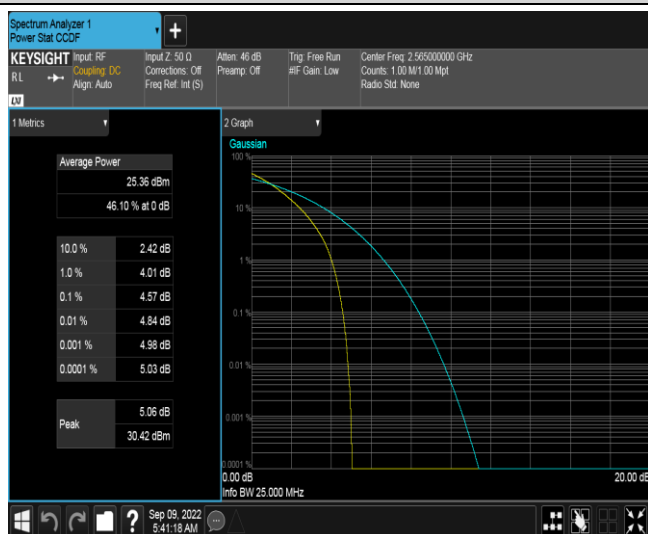

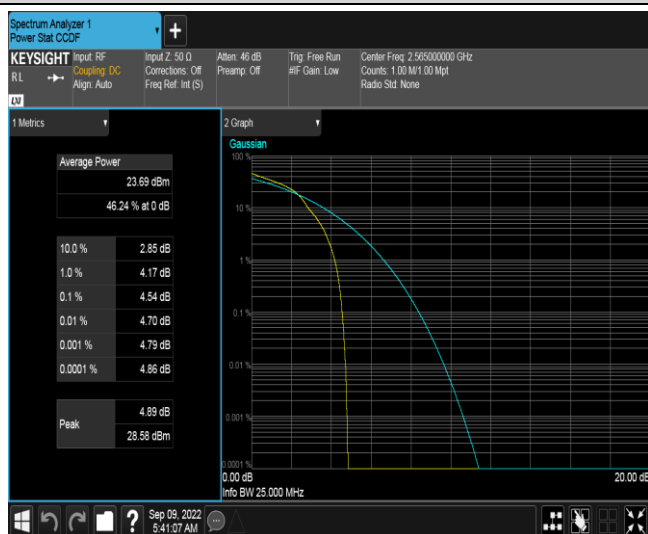


Band7-10MHz-16QAM-21100-50RB#0

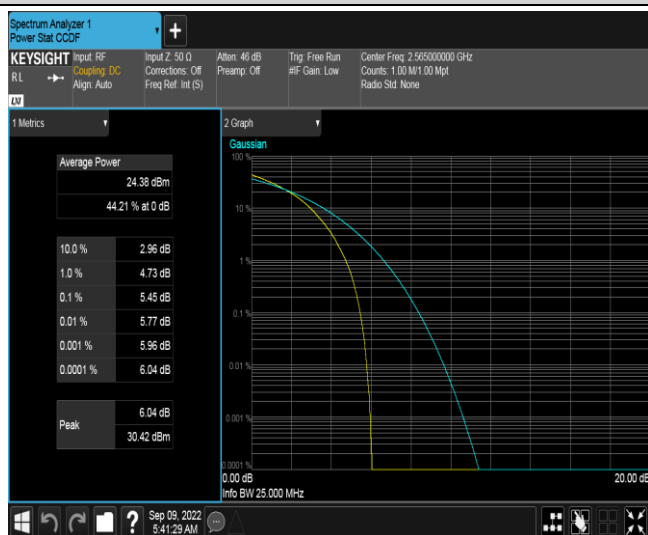
