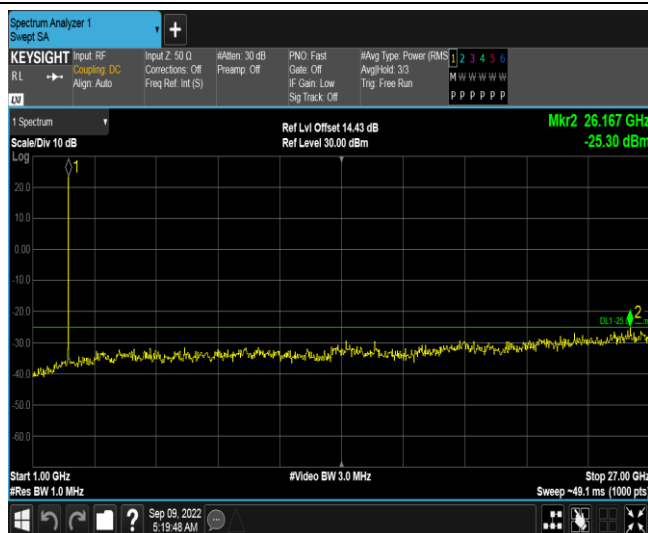

Band7-15MHz-16QAM-21100-1RB#0-Range1:30~1000MHz

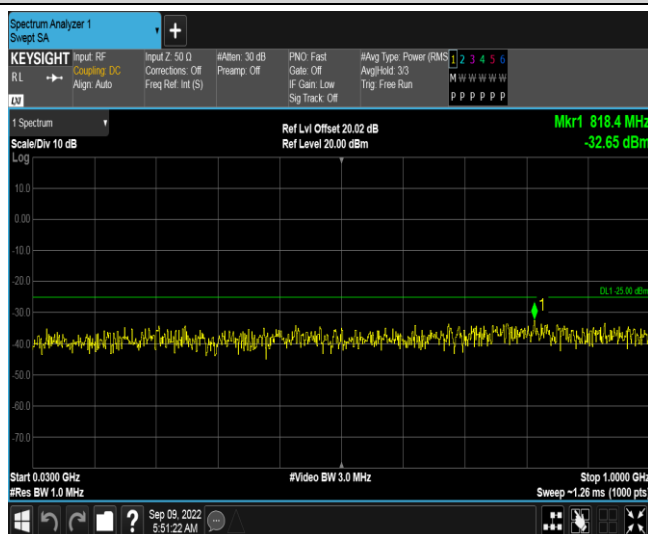
