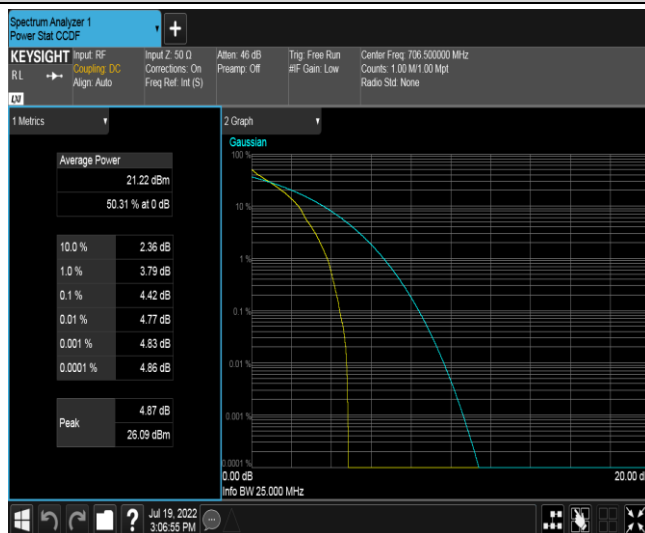

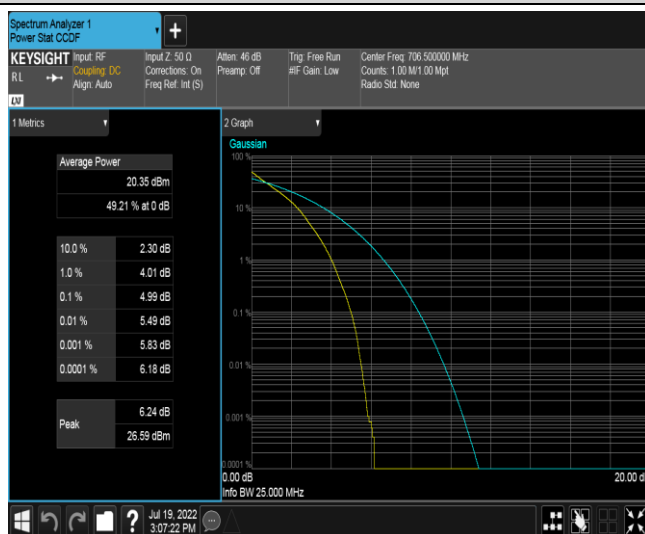

Band17-5MHz-QPSK-23755-25RB#0



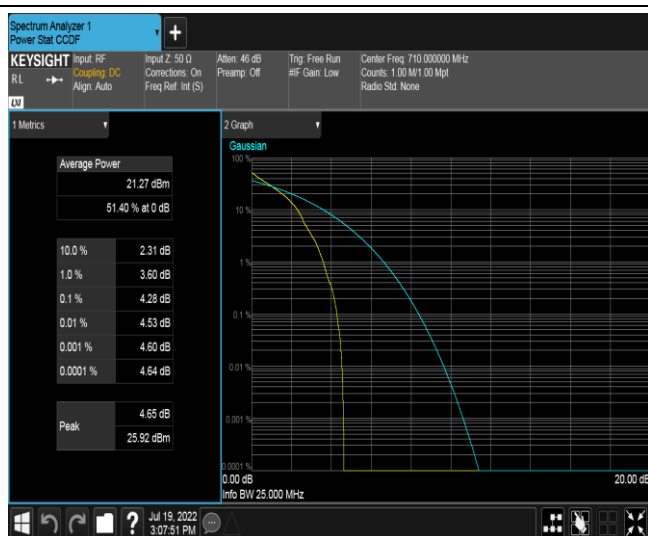
