Band17-10MHz-QPSK-23800-1RB#0-Range4:30~1000MHz

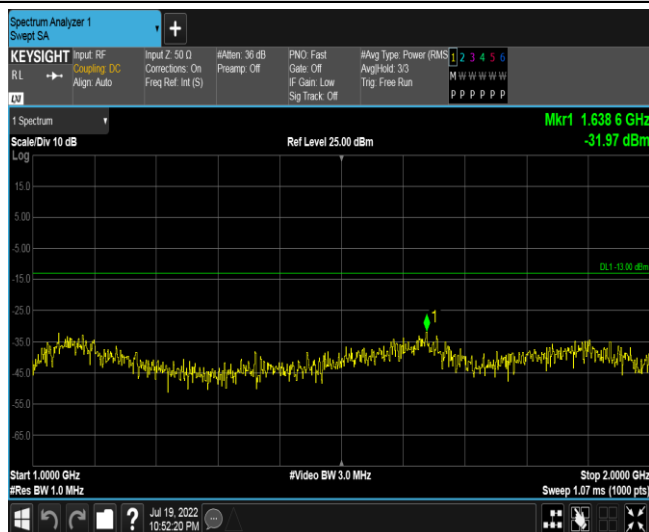
