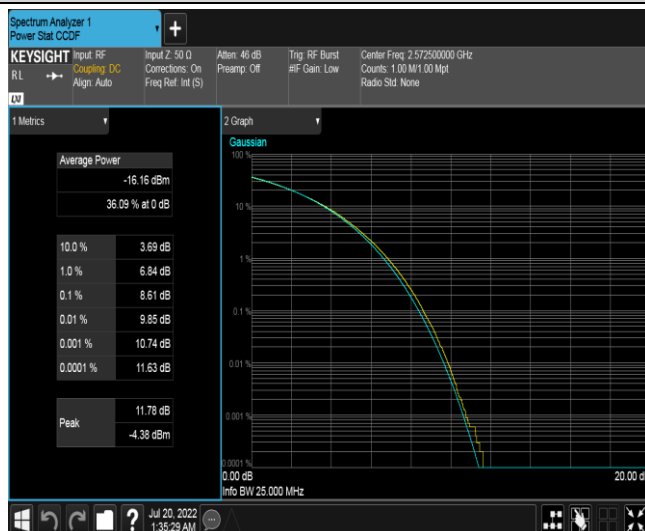

Band38-5MHz-QPSK-37775-25RB#0



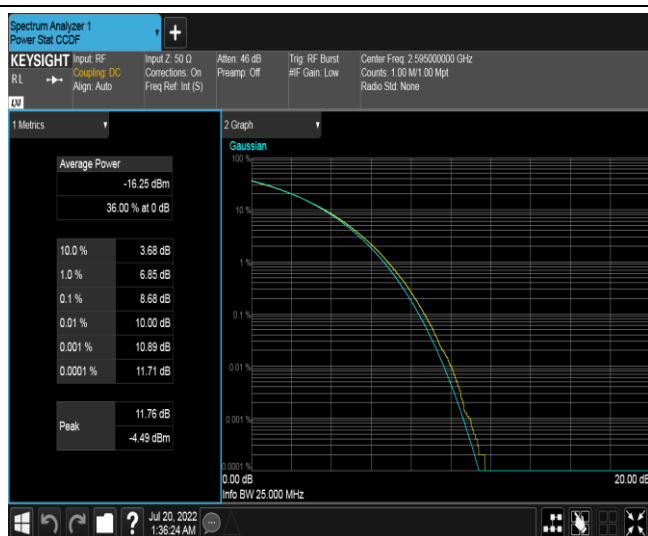
