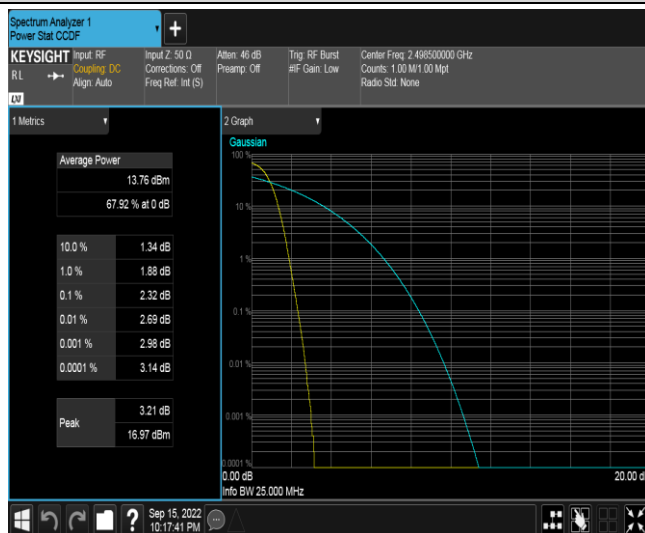

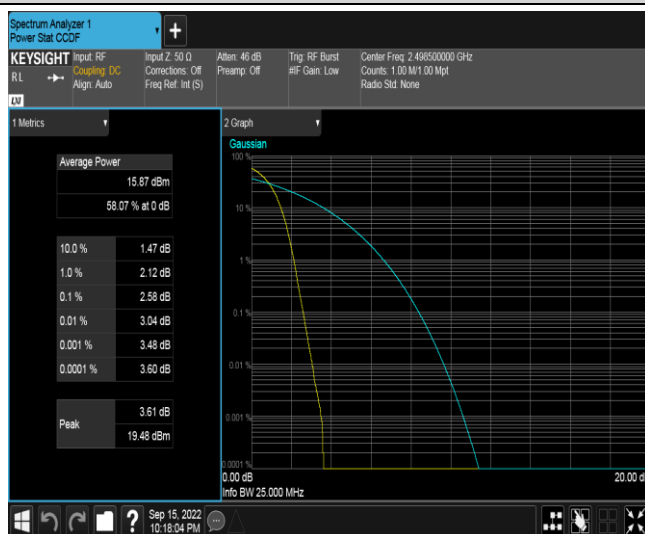

Band41-5MHz-QPSK-39675-25RB#0



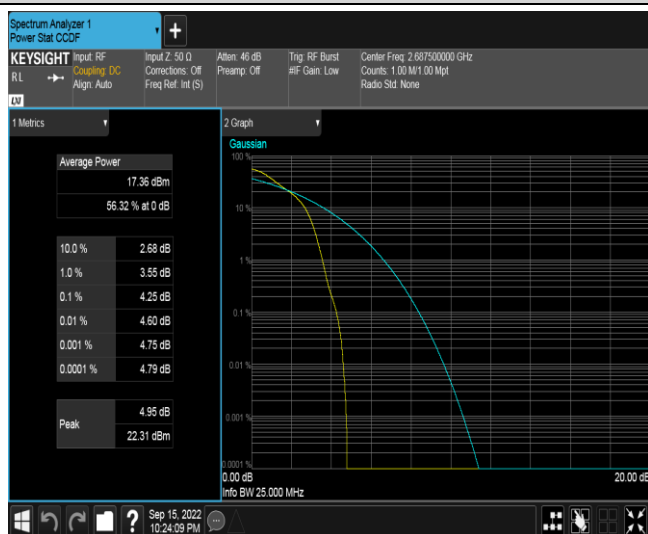
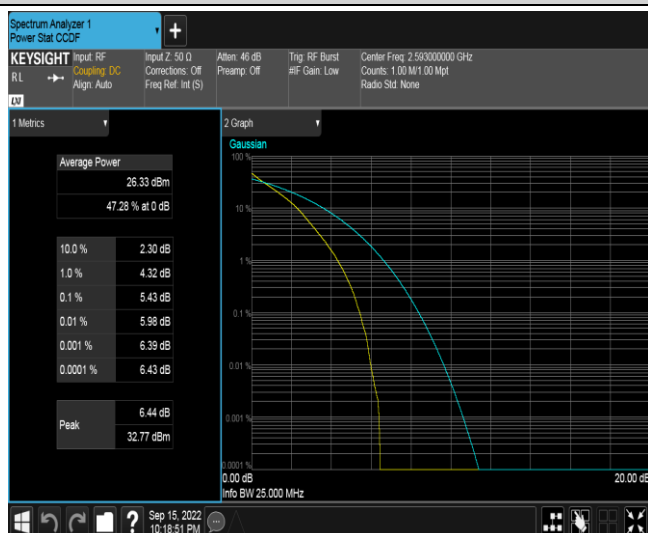
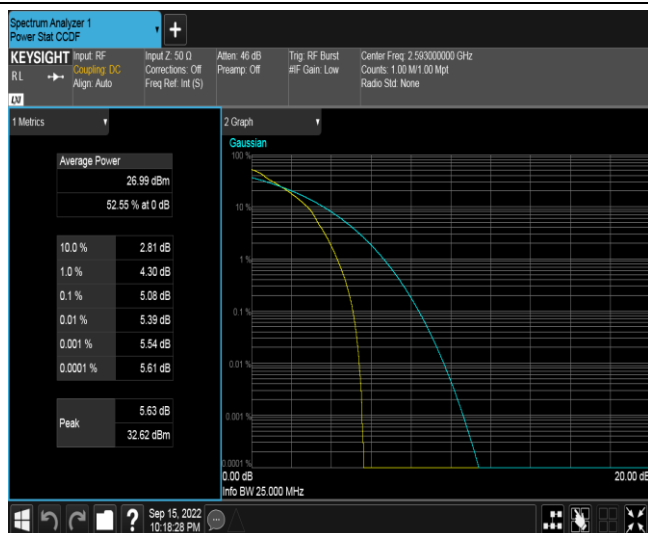

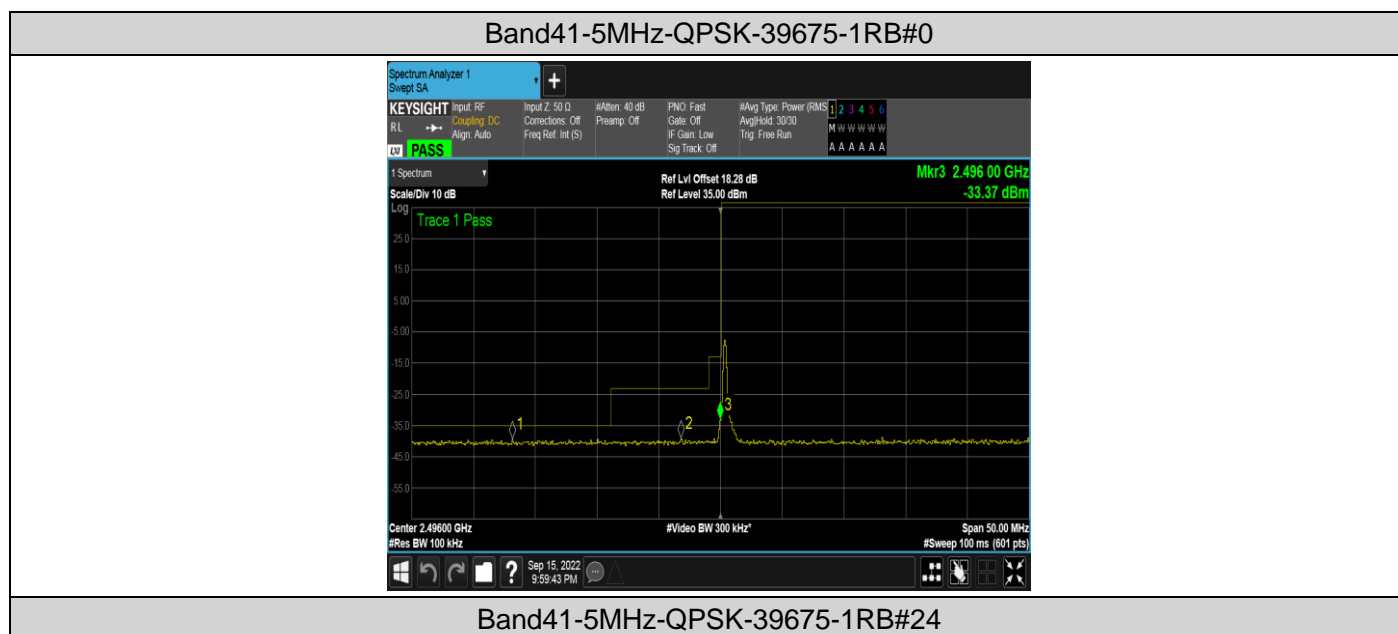
