1. The modular transmitter must have its own RF shielding.	Y	Yes, the modular transmitter provides RF shielding. Refer to exhibition external photo
2. The modular transmitter must have buffered modulation/data inputs (if such inputs are provided) to ensure that the module will comply with Part 15 requirements under conditions of excessive data rates or over-modulation.	Y	Buffered data input stage is internal to the module transmitter chipset (MM8108)
3. The modular transmitter must have its own power supply regulation.	Y	The modular transmitter has power regulation in the module transmitter chipset (MM8108)
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(b)(c). The antenna must either be permanently attached or employ a "unique" antenna coupler (at all connections between the module and the antenna, including the cable).	Y	The modular transmitter meets the FCC antenna requirements; unique antenna connector / permanently attached antenna. Refer to the photo of the antenna as shown in the test report.
5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing. This is intended to demonstrate that the module is capable of complying with Part 15 emission limits regardless of the device into which it is eventually installed.	Y	The modular transmitter was tested in a stand-alone configuration. Refer to section photographs of test configuration in the test report.
6. The modular transmitter must be equipped with either a permanently affixed label or must be capable of electronically displaying its FCC identification number in accordance with 15.212 (a)(1)(vi)(A) / (B).	Y	The module is too small for a label that includes the FCC ID, it is however included in the datasheet and User Guides along with instructions on how to include the label for the end product.
7. The modular transmitter must comply with any specific rule or operating requirements applicable to the transmitter and the manufacturer must provide adequate instructions along with the module to explain any such requirements. A copy of these instructions must be included in the application for equipment authorization. For example, there are very strict operational and timing requirements that must be met before a transmitter is authorized for operation under Section 15.231. For instance, data transmission is prohibited, except for operation under Section 15.231(e), in which case there are separate field strength level and timing requirements. Compliance with these requirements must be assured.	Y	The modular transmitter is compliant with all applicable FCC rules.
