1. The modular transmitter must have its own RF shielding.	<i>Y</i>	Yes, the modular transmitter provides RF shielding. Refer to exhibition external photo
2. The modular transmitter must have buffered modulation/data inputs (if such inputs are provided) to ensure that the module will comply with Part 15 requirements under conditions of excessive data rates or over-modulation.	<i>Y</i>	Buffered data input stage is internal to the module transmitter chipset (MM6108)
3. The modular transmitter must have its own power supply regulation.	<i>Y</i>	The modular transmitter has power regulation in the module transmitter chipset (MM6108)
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(b)(c).
