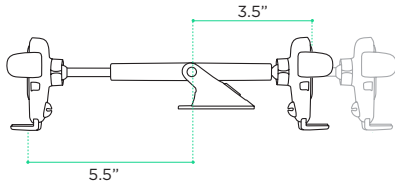


UNIVERSAL WIRELESS CHARGING CAR MOUNT

DASH | WINDSHIELD | VENT CAR MOUNT

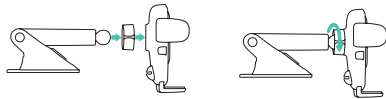
DASH INSTALLATION

ASSEMBLING THE MOUNT



Arm extends from 3.5"-5.5"

1. Connect the mount cradle to the ball joint.
2. Tighten the cradle knob.



ATTACHING THE MOUNT

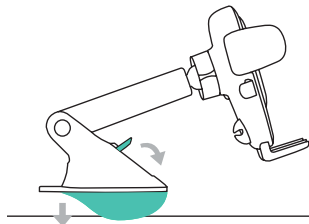
Choose an installation method: dashboard/flat surface (A) or windshield/curved glass (B).

[Option A]

DASHBOARD OR FLAT SURFACE INSTALLATION

Choose a flat location on the vehicle's dashboard and wipe any dust or debris from the surface.

1. Peel off the film on the dashboard and evenly press onto the desired installation location. Then push the locking lever down to engage suction. Wait at least 20 minutes.



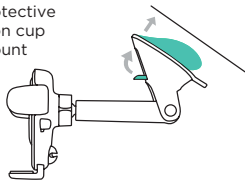
The pad is mounted with a semi-permanent adhesive tape, when removing the pad, please use caution

[Option B]

WINDSHIELD OR CURVED GLASS INSTALLATION

Choose a location on the windshield and wipe any dust or debris from the surface.

1. Peel off the protective film on the suction cup and press the mount firmly onto the windshield.



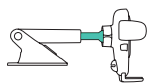
2. Pushing the locking lever down to engage suction.

ADJUSTING THE MOUNT



Cradle Knob

To rotate the cradle, loosen the cradle knob. Tighten to lock into desired position.

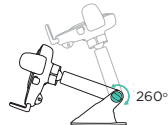


Telescopic Arm

To extend the arm, simply pull it outward and slide it into desired position.

Pivot Knob

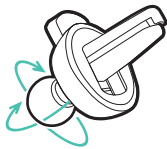
Turning the pivot knob allows you to adjust the telescopic arm. Tighten to secure the arm in place.



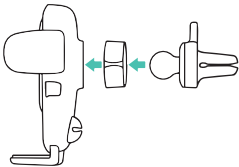
VENT INSTALLATION

ASSEMBLING THE MOUNT

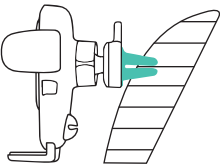
Mount rotates 360° for optimal viewing angles.



1. Connect the cradle to the vent mount and tighten the cradle knob.



2. Push the mount all the way onto the air vent blades.



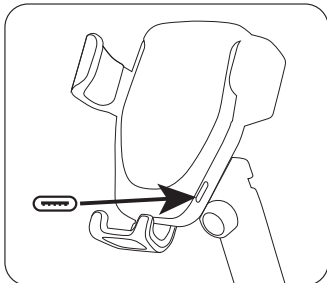

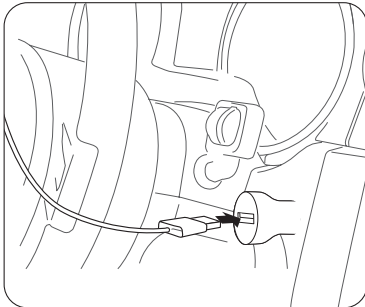

CABLE INSTALLATION

Locate the charging port at the bottom of the mount and connect the cable included in the pack as shown.



Connect USB cable to your car charger (sold separately) to power charge your phone.
