Formula: Pd = (Pout*G)/(4* π *r²)

Where:

Pd = power density in mW/cm²,

Pout = output power to antenna in mW;

G = gain of antenna in linear scale,

 $\pi = 3.14$;

R = distance between observation point and center of the radiator in cm

Pd id the limit of MPE, 1 mW/cm2. If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

Software provided by client enabled the EUT to transmit and receive data at lowest, middle and highest channel individually.

Conclusion: the max result : $0.00012 \le 1.0$ compliance with FCC's RF Exposure. Summary: Since the ERP (effective radiated power) operated at < 1.5 GHz is less than 1.5 watts and > 1.5 GHz is less than 3 watts, the routine environmental evaluation is not required, and the MPE result calculated for this device complies with the MPE limit as specified in 47 CFR §1.1310.
