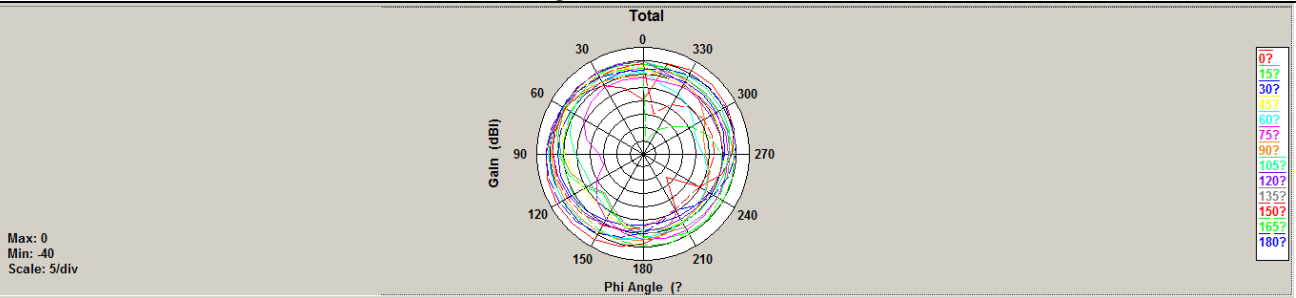

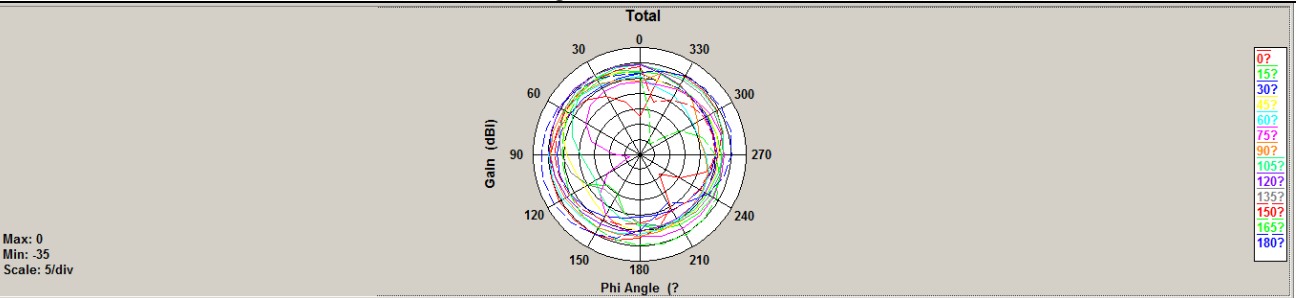

2D POLAR RADIATION PATTERN

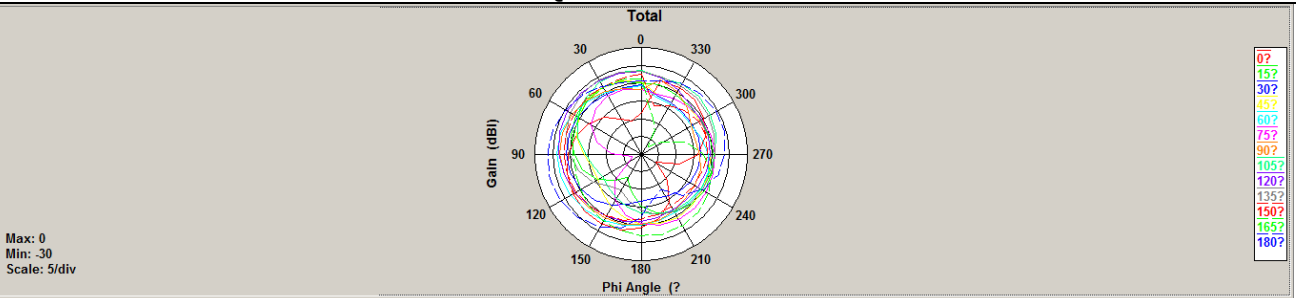

FREQUENCY=2500MHZ

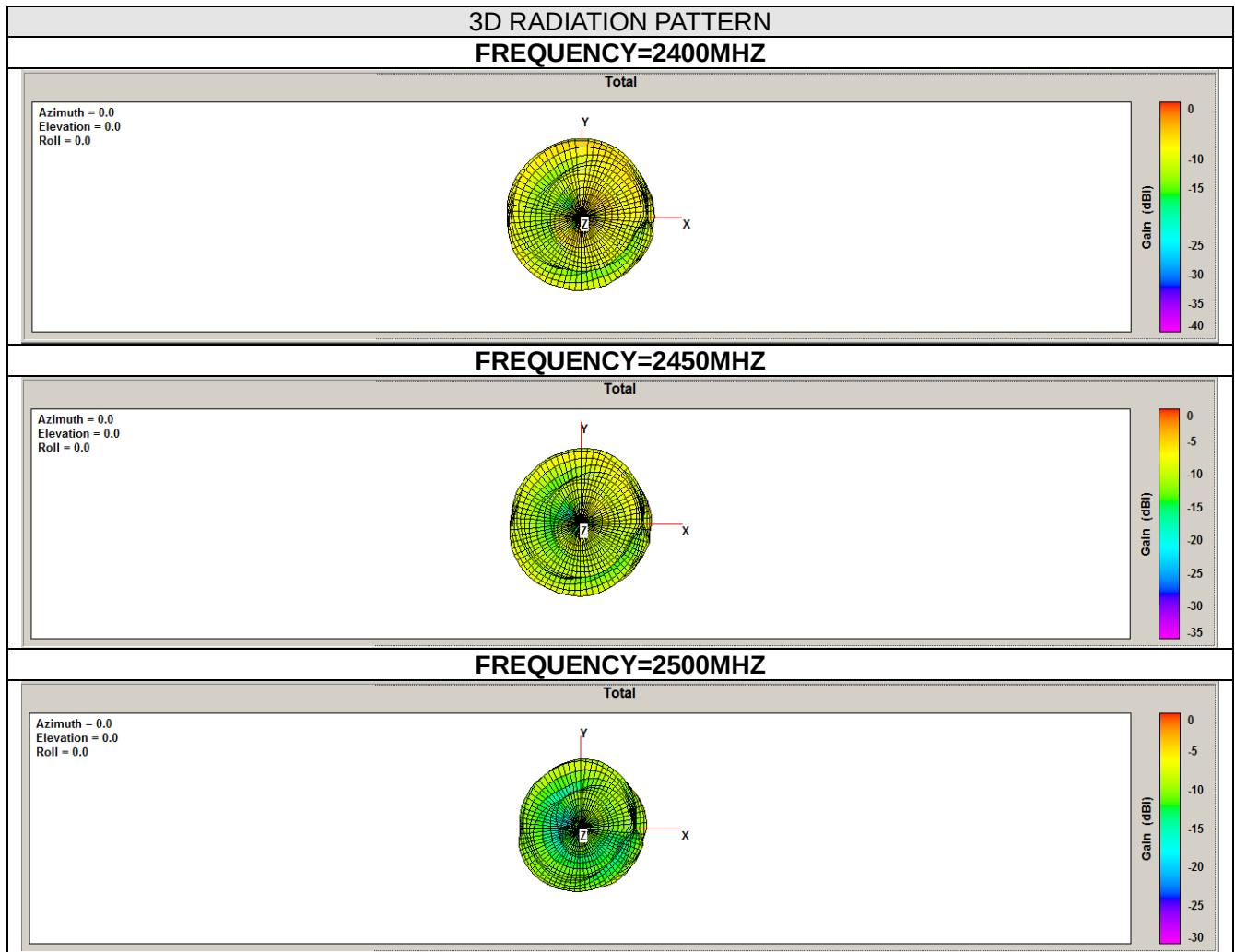
