

Installation and use manual of kid's balance bike




1.Main parts of kid's balance bike :





2.Instruction of light and music :

A.Turn-on mode :

Press and hold () for 1 second to power on.

1.Lighting selection:


a : Short press () once to select the light color.

b : In the power-on state, press and hold () for 2 seconds to select the lighting mode.

Notes: (1) The color types are divided into seven colors: red, green, blue, yellow, purple, blue and white.

(2) Lighting modes are divided into: flowing water, alternating, colorful, and collision.


2.Music selection:

It will automatically enter the bluetooth mode in the power-on state, and short press the () key to enter the TF card.

Notes: (1) In Bluetooth mode, you can play mobile music by connecting to the mobile phone.

(2) Built-in TF card, parents can download it according to their children's preferences. The download method can be connected to the computer with a data cable and find the music they like.

B.Turn-off mode:

Press and hold () for 5 seconds to automatically enter the shutdown state, or the balance bike will automatically shut down after being stationary for 10 minutes.

C.Charging Mode:

Connect the 5V charger, the light is red during the charging process, and the light is off when fully charged.

3.Kid's Balance Bike Assembly Instructions

(1) Open the carton and inspect all parts.

(It adopts 85% packaging, in order to facilitate the assembly and use of customers, the assembly steps are minimized, and it only takes two steps to assemble, you can enjoy riding fun.)



(2) Install the handlebar

As shown in the picture, loosen the four screws on the handlebar stand and insert them into the handlebar to adjust to the appropriate position, and then tighten the four bolts with an M4 wrench.



(3) Install the saddle

Open the seat tube quick release, insert the saddle into the seat tube of the frame, adjust the riding height to make it suitable for the height of the child, pay attention to the safety line of the saddle tube, do not expose it, and fasten the seat tube quick release.



(4) Riding

Please ride under the guidance of a parent.



4.Warning

- (1) Before use, the guardian should read the instruction carefully. If you do not follow the instruction, it may affect the safety of children. The instruction should be kept permanently for future reference.
- (2) Suitable for age (3~5 years old).
- (3) Max loading : 50KG.
- (4) It is not a means of transportation, and it is not allowed to ride on the road.
- (5) Wear a helmet and protective gear when riding.
- (6) Please check the product for damage before use.
- (7) Before use, please confirm that the product is installed in a solid state. When replacing accessories, please use the original accessories to ensure safety.
- (8) Please avoid children touching the ring and other moving parts during riding. Please adjust the saddle to a suitable height for ease of use.
- (9) When using this product, please wear close-fitting clothing.
- (10) Do not use this product on slopes and other dangerous locations.
- (11) Use under adult supervision.

5.Maintenance

1. After unpacking, packaging materials and protective materials must be stored in the designated garbage bin.
2. Check whether the fastening parts are tight before each use.
- 3.If the inspection is not carried out, it may cause harm to the child.
4. If the parts are not installed correctly, it will cause danger.
- 5.Do not overload.
6. Avoid using this product in humid, cold, hot environments.
7. Avoid collision with other hard objects.
8. There is no need to pack the painted surface, otherwise the surface will tarnish or peel.
9. Use natural oil to wipe the welded parts to prevent rust.
