

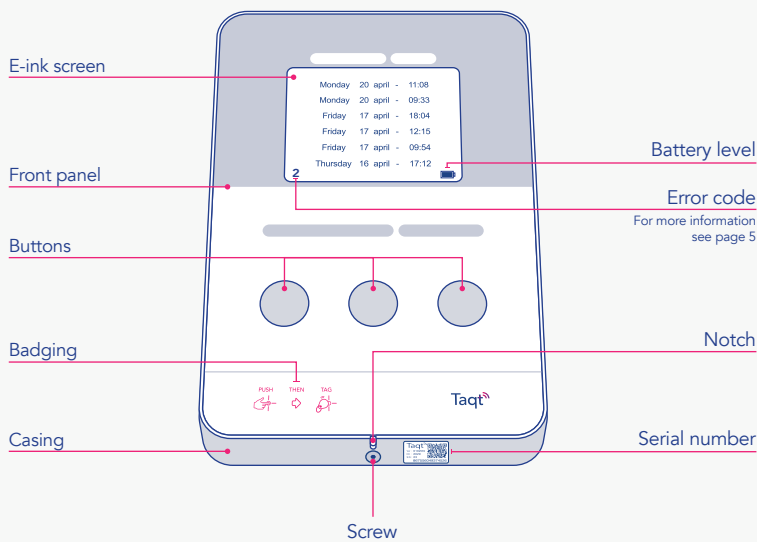

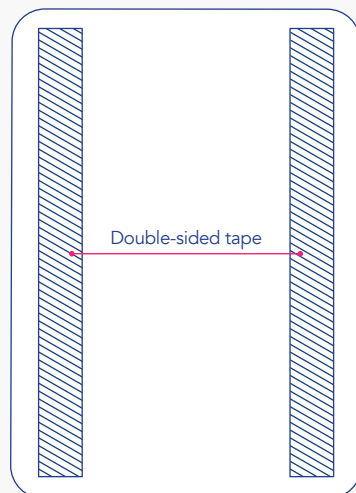

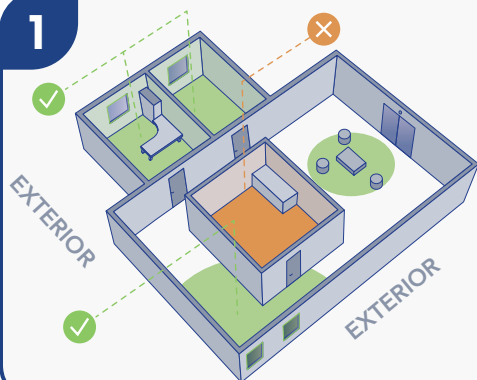

Meet at the place of installation

We recommend to install the terminal :



- Close to the entrance of the building
- Close to a window or opening

It is not recommended to install the terminal :



- In a blind, windowless room
- In basements, wardrobes
- In a building with very thick walls or metal sheet

Once you are in the room that meets these conditions, move on to the next step.

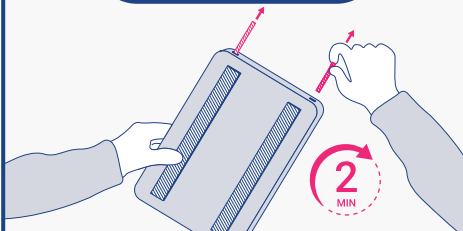

Choose a **smooth, dry and clean surface** on which to place your terminal.

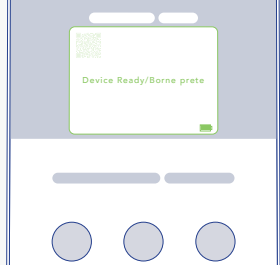
Warning: Before gluing the terminal, perform the **connectivity test** in the room where you want to install it.

Remove the **two tabs** to turn it on. Wait between 30 seconds and 5 minutes until the terminal screen refreshes.

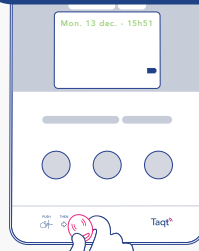




Refer to the "**Use**" section on page 6 for badging. Badge the terminal, the screen displays the **current date and time**, the test is successful, proceed to step 3.






Enter the **DC** and **S/N** number in the **paper table** (at the end of the manual), written on the label, and its position in the building. This will be used to activate your terminals online.

Activate your terminal by indicating its position in the **"My sensors"** module of the online platform. Request your access to Taqt support, if you have not received it.

1- IMPORTANT SAFETY INSTRUCTIONS

Do not use the TaqtOne in a wet environment where the device may be exposed to dripping, splashing or direct water. Details of the legal warranty.

1° Be fit for the purpose ordinarily expected of similar goods and, where applicable : (a) correspond to the description given by the seller and possess the qualities which the seller has presented to the buyer in the form of a sample or model; (b) have the qualities which a buyer may legitimately expect, having regard to the public statements made by the seller, by the producer or by his representative, in particular in advertising or labelling;

2° Or have the characteristics defined by mutual agreement between the parties or be suitable for any special use sought by the buyer, brought to the attention of the seller and accepted by the latter.

When you act under the legal guarantee of conformity

- you have a period of one year from the date of delivery of the goods to take action

- you can choose between repairing or replacing the goods, subject to the cost conditions set out in Article L. 211-9 of the Consumer Code

- you are exempted from proving the existence of a lack of conformity of the goods during the six months following delivery of the goods. This period is extended to twenty-four months from 18 March 2016, except for second-hand goods.

Guarantee for hidden defects

Under Article 1641 of the French Civil Code, the seller is liable for hidden defects in the item sold that make it unsuitable for its intended use, or that reduce this use to such an extent that the buyer would not have purchased it, or would have paid a lower price for it, if he had known about them.

In this case, you can choose between the cancellation of the sale or a reduction of the sale price in accordance with Article 1644 of the Civil Code. The action resulting from reductive defects must be brought by the purchaser within two years of the discovery of the defect (Article 1648 of the Civil Code);

Other provisions :

In France, when the buyer asks the seller, during the course of the commercial guarantee granted to him at the time of the acquisition or repair of a movable good, for a repair covered by the guarantee, any period of immobilisation of at least seven days is added to the duration of the guarantee which remained to run. This period runs from the date of the buyer's request for intervention or from the time the item in question is made available for repair; if this availability is subsequent to the request for intervention (Article L. 211-16 of the Consumer Code).
