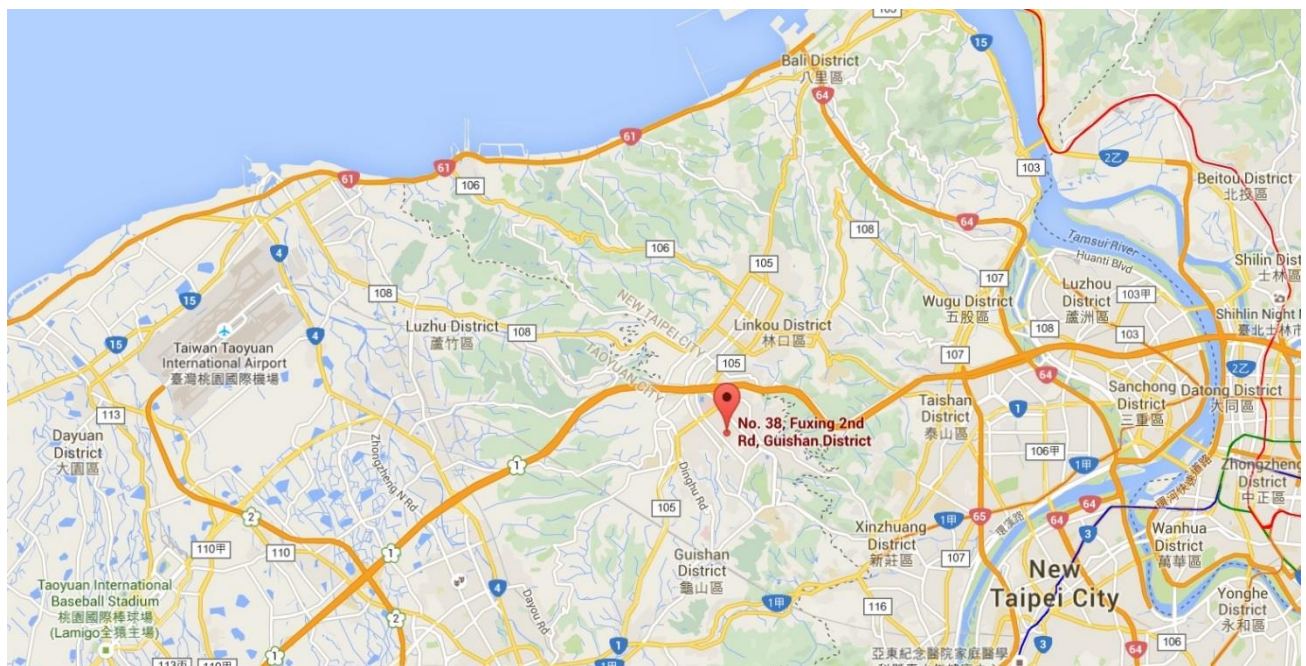
1. INTRODUCTION

Note: Frequencies selected for statistical performance check should include several frequencies within the radar detection bandwidth and frequencies near the edge of the radar detection bandwidth. For 802.11 devices it is suggested to select frequencies in each of the bonded 20 MHz channels and the channel center frequency.

3.2. DFS Devices Requirements

Per FCC KDB 905462 D02 UNII DFS Compliance Procedures New Rules v02 the following are the requirements for Client Devices:

- a) A Client Device will not transmit before having received appropriate control signals from a Master Device.
- b) A Client Device will stop all its transmissions whenever instructed by a Master Device to which it is associated and will meet the Channel Move Time and Channel Closing transmission time requirements. The Client Device will not resume any transmissions until it has again received control signals from a Master Device.
- c) If a Client Device is performing In-Service Monitoring and detects a Radar Waveform above the DFS Detection Threshold, it will inform the Master Device. This is equivalent to the Master Device detecting the Radar Waveform.
- d) Irrespective of Client Device or Master Device detection the Channel Move Time and Channel Closing Transmission Time requirements remain the same.
- e) The client test frequency must be monitored to ensure no transmission of any type has occurred for 30 minutes. Note: If the client moves with the master, the device is considered compliant if nothing appears in the client non-occupancy period test. For devices that shut down (rather than moving channels), no beacons should appear.

Channel Move Time and Channel Closing Transmission Time requirements are listed in the following table.

Note 2: The Channel Closing Transmission Time is comprised of 200 milliseconds starting at the beginning of the Channel Move Time plus any additional intermittent control signals required to facilitate a Channel move (an aggregate of 60 milliseconds) during the remainder of the 10 second	

period. The aggregate duration of control signals will not count quiet periods in between transmissions.

Note 3: During the U-NII Detection Bandwidth detection test, radar type 0 should be used. For each frequency step the minimum percentage of detection is 90 percent. Measurements are performed with no data traffic.

3.3. DFS Detection Threshold Values

The DFS detection thresholds are defined for Master devices and Client Devices with In-service monitoring. These detection thresholds are listed in the following table.

Note 1: This is the level at the input of the receiver assuming a 0 dBi receive antenna. Note 2: Throughout these test procedures an additional 1 dB has been added to the amplitude of the test transmission waveforms to account for variations in measurement equipment. This will ensure that the test signal is at or above the detection threshold level to trigger a DFS response. Note3: EIRP is based on the highest antenna gain. For MIMO devices refer to KDB Publication 662911 D01.

3.4. Parameters of DFS Test Signals

This section provides the parameters for required test waveforms, minimum percentage of successful detections, and the minimum number of trials that must be used for determining DFS conformance. Step intervals of 0.1 microsecond for Pulse Width, 1 microsecond for PRI, 1 MHz for chirp width and 1 for the number of pulses will be utilized for the random determination of specific test waveforms.

The parameters for this waveform are randomly chosen. Thirty unique waveforms are required for the Long Pulse Radar Type waveforms. If more than 30 waveforms are used for the Long Pulse Radar Type waveforms, then each additional waveform must also be unique and not repeated from the previous waveforms.

For the Frequency Hopping Radar Type, the same Burst parameters are used for each waveform. The hopping sequence is different for each waveform and a 100-length segment is selected from the hopping sequence defined by the following algorithm:

The first frequency in a hopping sequence is selected randomly from the group of 475 integer frequencies from 5250 – 5724MHz. Next, the frequency that was just chosen is removed from the group and a frequency is randomly selected from the remaining 474 frequencies in the group. This process continues until all 475 frequencies are chosen for the set. For selection of a random frequency, the frequencies remaining within the group are always treated as equally likely.

3.5. Conducted Test Setup

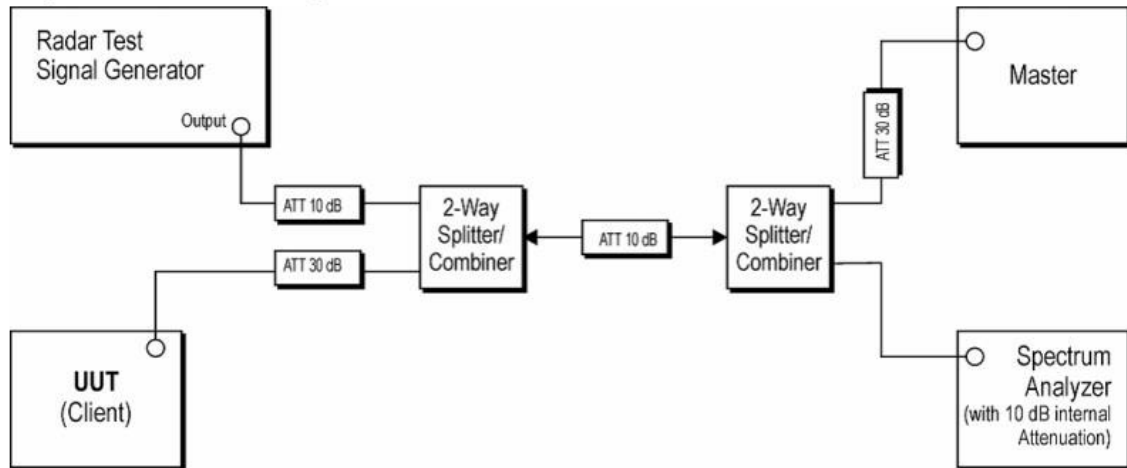


Figure 3-1: Conducted Test Setup where UUT is a Client and Radar Test Waveforms are injected into the Masters

The FCC KDB 905462 D02 UNII DFS Compliance Procedures New Rules v01 describes a radiated test setup and a conducted test setup. The conducted test setup was used for this testing. Figure 3-1 shows the typical test setup.

5.2. Radar Waveform Calibration

5.2.1. Calibration Setup

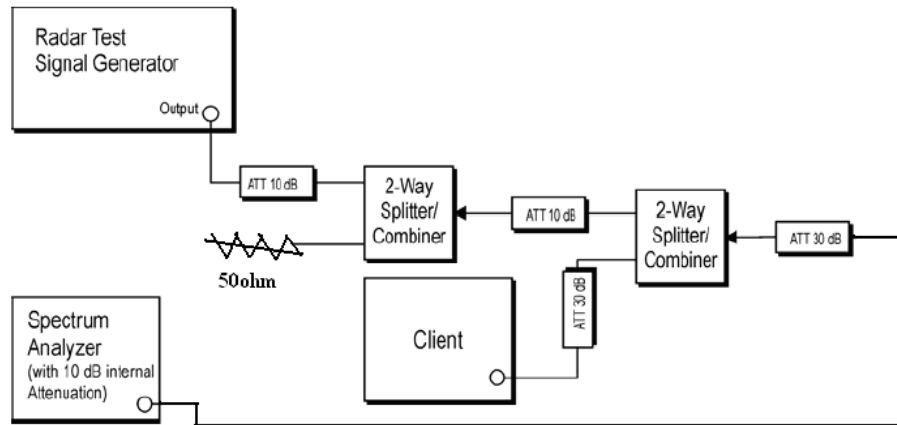


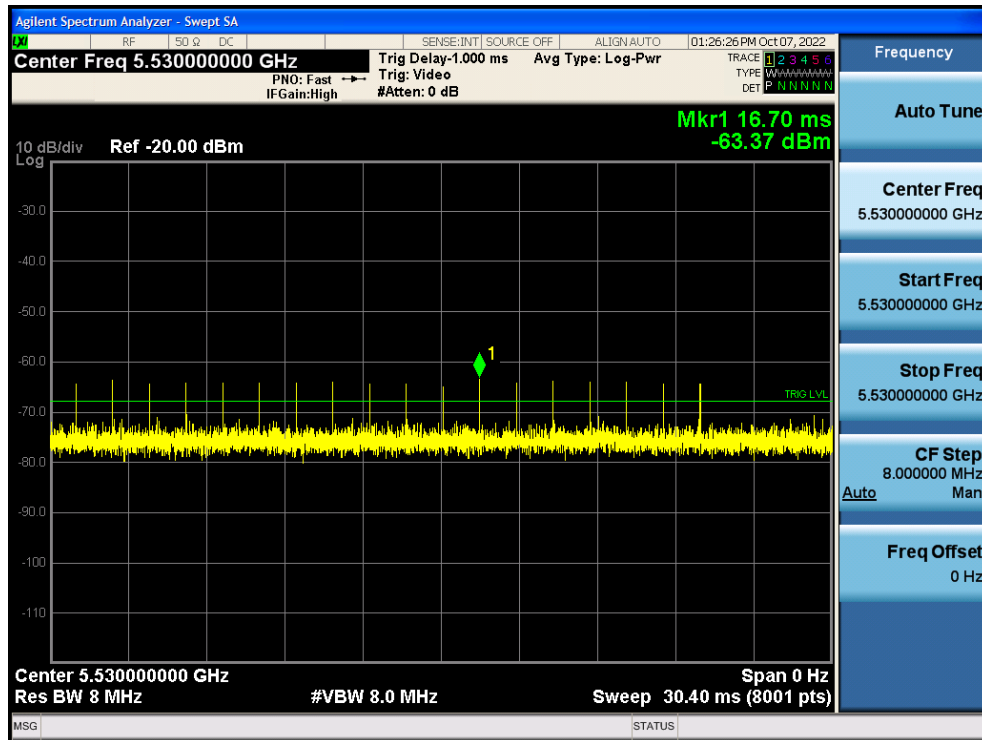
Figure 3-2: Conducted Test Setup

The conducted test setup was used for this calibration testing. Figure 3-2 shows the typical test setup.

5.2.2. Calibration Procedure

The Interference Radar Detection Threshold Level is $(-64\text{dBm}) + (0) [\text{dBi}] + 1 \text{ dB} = -63 \text{ dBm}$ that had been taken into account the output power range and antenna gain. The above equipment setup was used to calibrate the conducted Radar Waveform. A vector signal generator was utilized to establish the test signal level for each radar type. During this process there were replace 50ohm terminal form Master and Client device and no transmissions by either the Master or Client Device. The spectrum analyzer was switched to the zero span (Time Domain) at the frequency of the Radar Waveform generator. Peak detection was used. The spectrum analyzer resolution bandwidth (RBW) and video bandwidth (VBW) were set to at least 3MHz. The vector signal generator amplitude was set so that the power level measured at the spectrum analyzer was $(-64\text{dBm}) + (0) [\text{dBi}] + 1 \text{ dB} = -63\text{dBm}$. Capture the spectrum analyzer plots on short pulse radar types, long pulse radar type and hopping radar waveform.

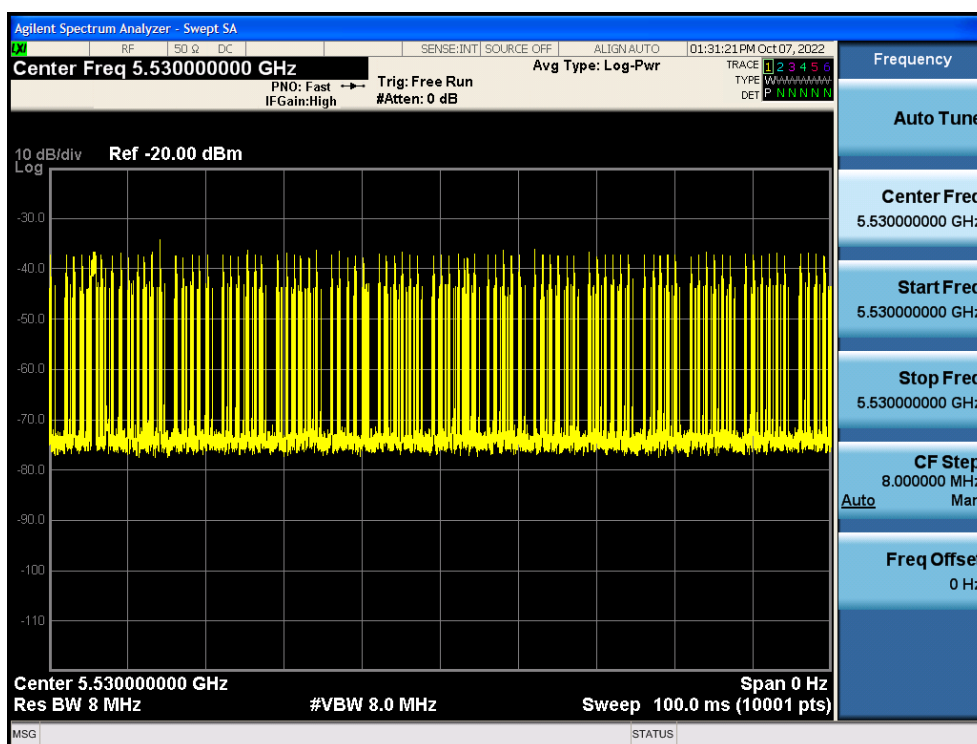
Radar #0 DFS detection threshold level and the burst of pulses on the 5530MHz



5.3. Channel Loading Test Result

System testing was performed with the designated MPEG test file that streams full motion video from the Master to the Client in full motion video mode using the media player with the V2.61 Codec package. This file is used by IP and Frame based systems for loading the test channel during the In-service compliance testing of the U-NII device

5.4. In-Service Monitoring for Channel Move Time, Channel Closing Transmission Time and Non-Occupancy Period Measurement

5.4.1. Test Limit

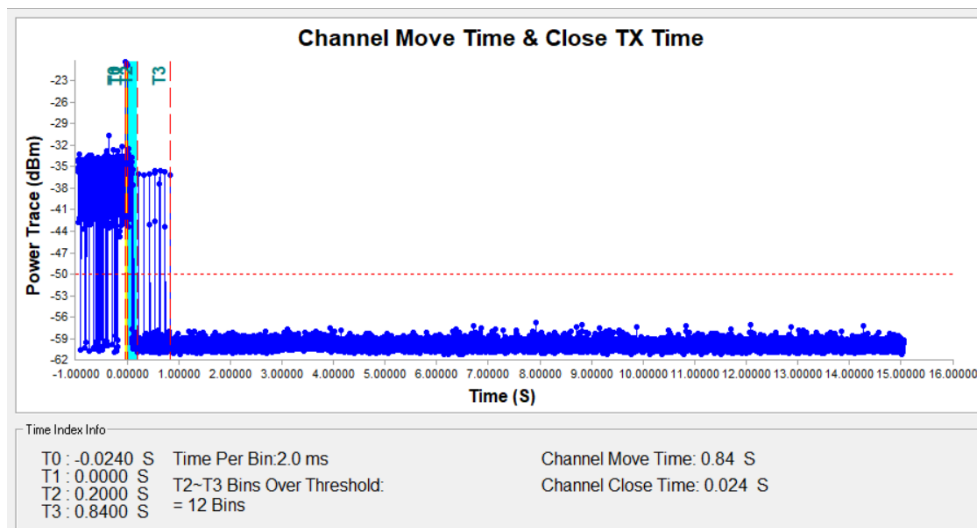
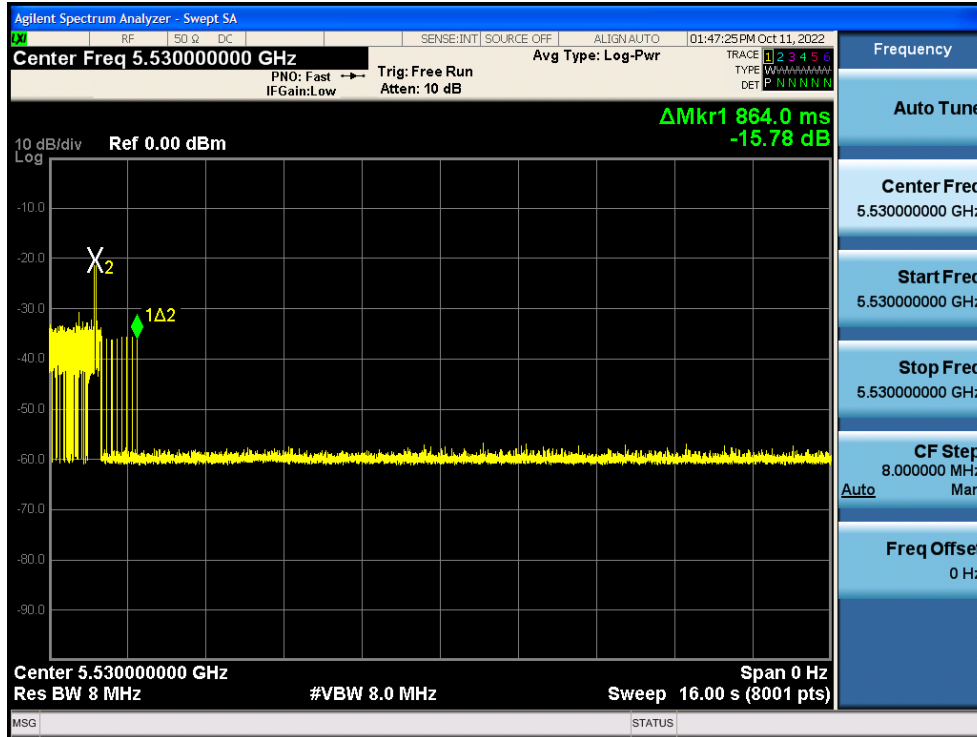
The EUT has In-Service Monitoring function to continuously monitor the radar signals. If the radar is detected, must leave the channel (Shutdown). The Channel Move Time to cease all transmissions on the current channel upon detection of a Radar Waveform above the DFS Detection Threshold within 10 sec. The total duration of Channel Closing Transmission Time is 260ms, consisting of data signals and the aggregate of control signals, by a U-NII device during the Channel Move Time. The Non-Occupancy Period time is 30 minute during which a Channel will not be utilized after a Radar Waveform is detected on that Channel.

5.4.2. Test Procedure Used

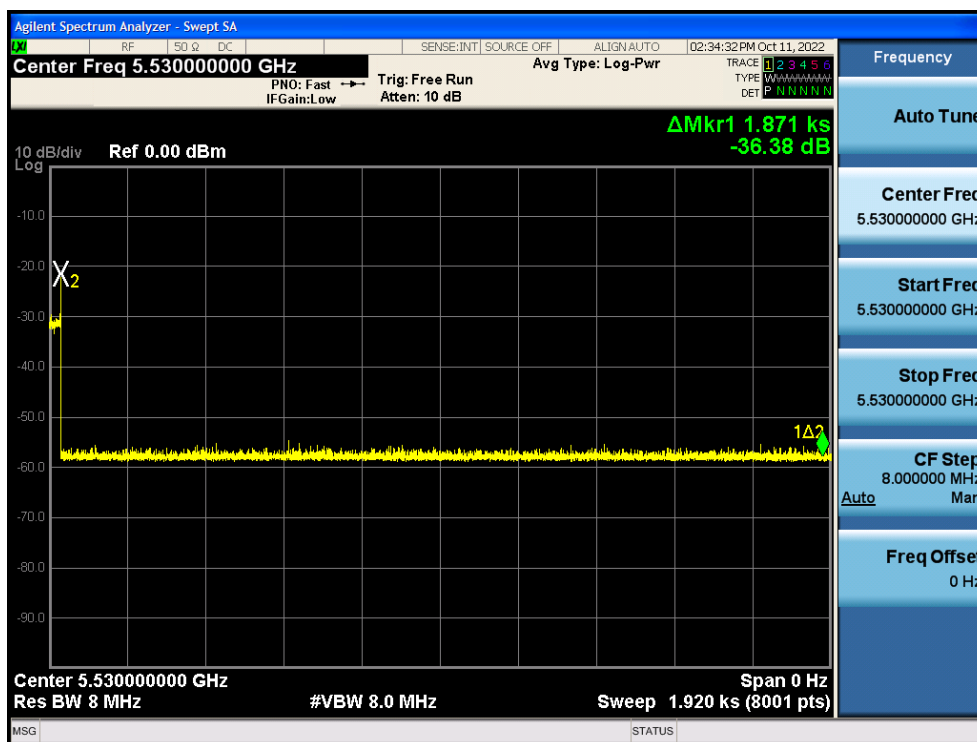
1. The test should be performed with Radar Type 0. The measurement timing begins at the end of the Radar Type 0.
2. When the radar burst with a level equal to the DFS Detection Threshold + 1dB is generated on the Operating Channel of the U-NII device. A U-NII device operating as a Master Device will associate with the Client Device at Channel. Stream the MPEG test file from the Master Device to the Client Device on the selected Channel for the entire period of the test. At time T0 the Radar Waveform generator sends a Burst of pulses for each of the radar types at Detection Threshold + 1dB.
2. Observe the transmissions of the EUT at the end of the radar Burst on the Operating Channel. Measure and record the transmissions from the EUT during the observation time (Channel Move Time).
3. Measurement of the aggregate duration of the Channel Closing Transmission Time method. With the spectrum analyzer set to zero span tuned to the center frequency of the EUT operating channel at the radar simulated frequency, peak detection, and max hold, the dwell time per bin is given by: $Dwell (1.5ms) = S (12 \text{ sec}) / B (8000)$; where Dwell is the dwell time per spectrum analyzer sampling bin, S is the sweep time and B is the number of spectrum analyzer sampling bins. An upper bound of the aggregate duration of the intermittent control signals of Channel Closing Transmission Time is calculated by: $40MHz: C (6.00 \text{ ms}) = N (4) \times Dwell (1.5 \text{ ms})$; where C is the Closing Time, N is the number of spectrum analyzer sampling bins showing a U-NII transmission and Dwell is the dwell time per bin.
4. Measure the UUT for more than 30 minutes following the channel close/move time to verify that the UUT does not resume any transmissions on this Channel.
