## 5 Radio Spectrum Technical Requirement

### 5.1 RF Exposure

#### 5.1.1 Test Requirement:

CFR 47 Part 1.1307, KDB 447498 D04 Interim General RF Exposure Guidance v01

Limit:

According to FCC Part1.1307 (b)(3): For single RF sources (i.e., any single fixed RF source, mobile device, or portable device, as defined in paragraph (b)(2) of this section): A single RF source is exempt if:

- (A) The available maximum time-averaged power is no more than 1 mW, regardless of separation distance. This exemption may not be used in conjunction with other exemption criteria other than those in paragraph (b)(3)(ii)(A) of this section. Medical implant devices may only use this exemption and that in paragraph (b)(3)(ii)(A);

#### 5.1.2 Conclusion

Thus, the EUT fulfil the 1mW exemption criteria.



## 5.2 RF Exposure

### 5.2.1 Test Requirement:

RSS-102 Section 2.5.1

Limit:

All transmitters are exempt from routine SAR and RF exposure evaluations provided that they comply with the requirements of sections 2.5.1 or 2.5.2 of RSS-102 Issue 5, March 2015. If the equipment under test (EUT) meets the requirements of sections 2.5.1 or 2.5.2, applicants are only required to submit a properly signed declaration of compliance.

SAR evaluation is required if the separation distance between the user and/or bystander and the antenna and/or radiating element of the device is less than or equal to 20 cm, except when the device operates at or below the applicable output power level (adjusted for tune-up tolerance) for the specified separation distance defined in Table 1.

Output power level shall be the higher of the maximum conducted or equivalent isotropically radiated power (e.i.r.p.) source-based, time-averaged output power. For controlled use devices where the 8 W/kg for 1 gram of tissue applies, the exemption limits for routine evaluation in Table 1 are multiplied by a factor of 5. For limb-worn devices where the 10-gram value applies, the exemption limits for routine evaluation in Table 1 are multiplied by a factor of 2.5. If the operating frequency of the device is between two frequencies located in Table 1, linear interpolation shall be applied for the applicable separation distance. For test separation distance less than 5 mm, the exemption limits for a separation distance of 5 mm can be applied to determine if a routine evaluation is required.

For medical implants devices, the exemption limit for routine evaluation is set at 1 mW. The output power of a medical implants device is defined as the higher of the conducted or e.i.r.p to determine whether the device is exempt from the SAR evaluation.

### 5.2.2 Conclusion

By using linear interpolation to determine the limit for the worse separation distance of  $\leq 5$  mm at

2402 MHz:

$$\text{Limit} = 4 + (2450 - 2402) \times ((7 - 4) / (2450 - 1900)) = 4.26 \text{ mW}$$

2442 MHz

$$\text{Limit} = 4 + (2450 - 2442) \times ((7 - 4) / (2450 - 1900)) = 4.04 \text{ mW}$$

2480 MHz:

$$\text{Limit} = 4 + (2480 - 2450) \times ((2 - 4) / (3500 - 2450)) = 3.94 \text{ mW}$$

The e.i.r.p is calculated with the formula:

$$10^{\wedge} ((\text{Conductive power} + \text{Antenna gain}) / 10)$$
