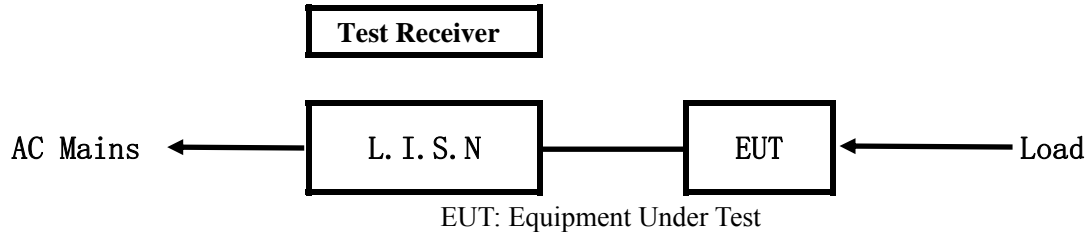

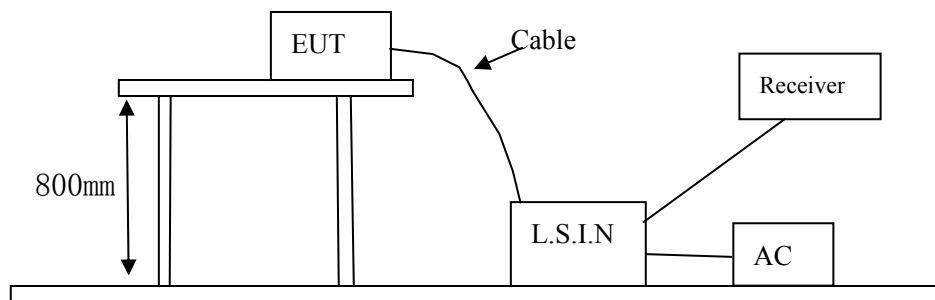


### 5.2 Test Method and test Procedure

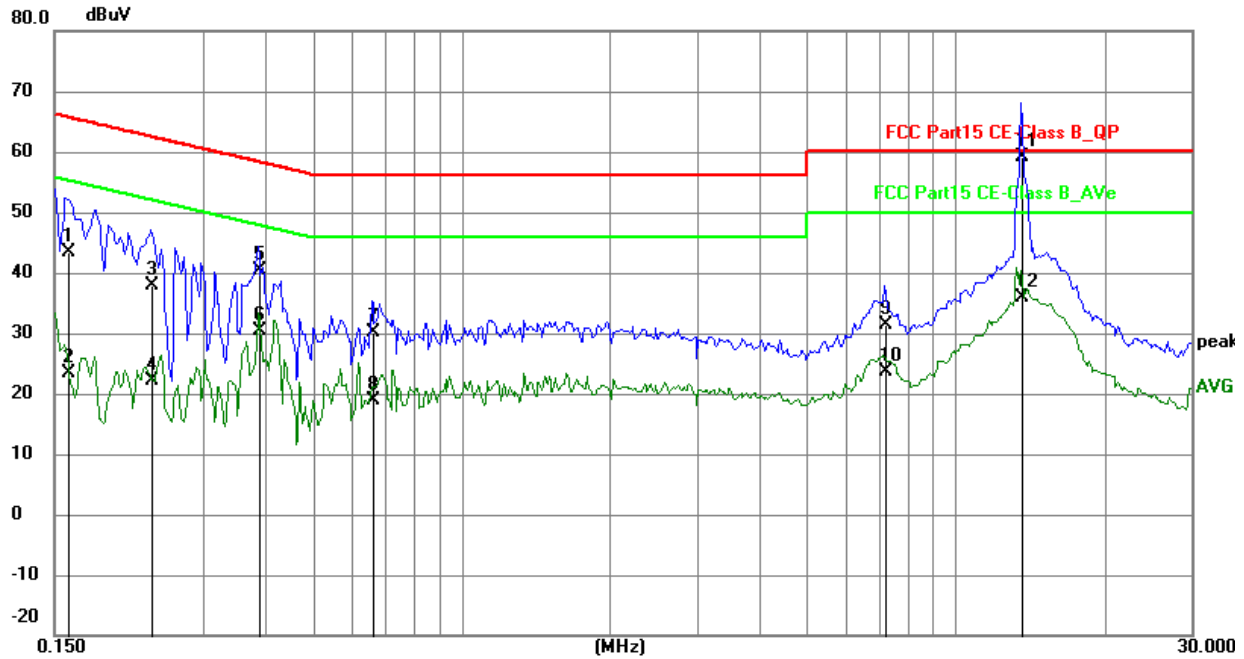

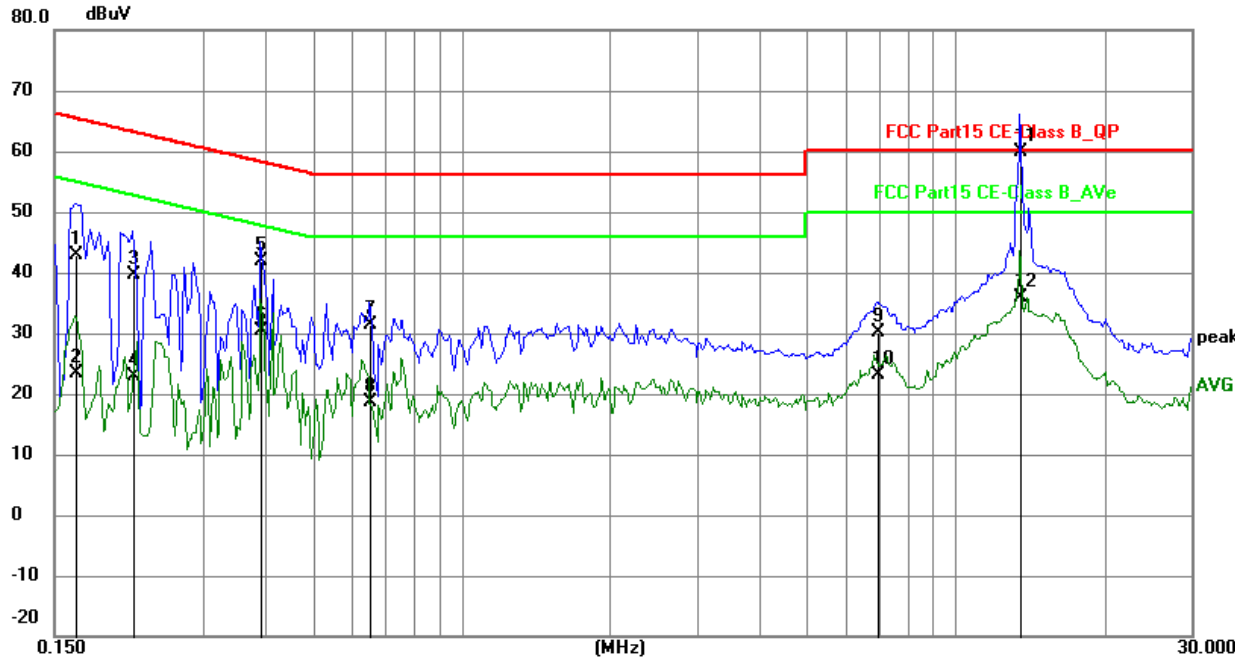

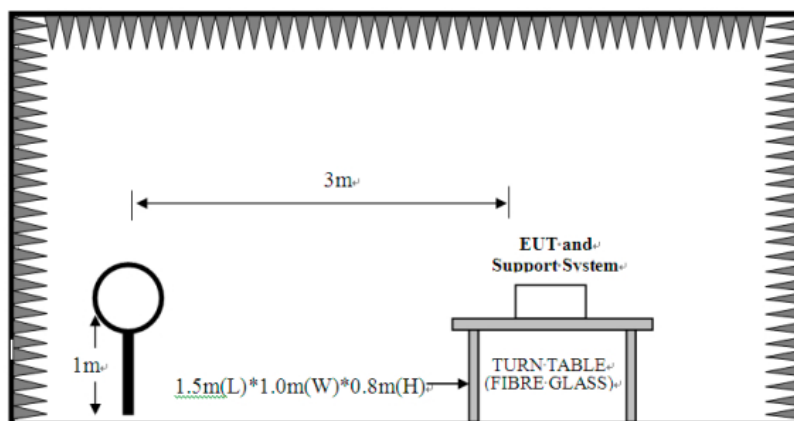
## 6 Radiated Emission Test

For radiated emissions from 9kHz to 30MHz



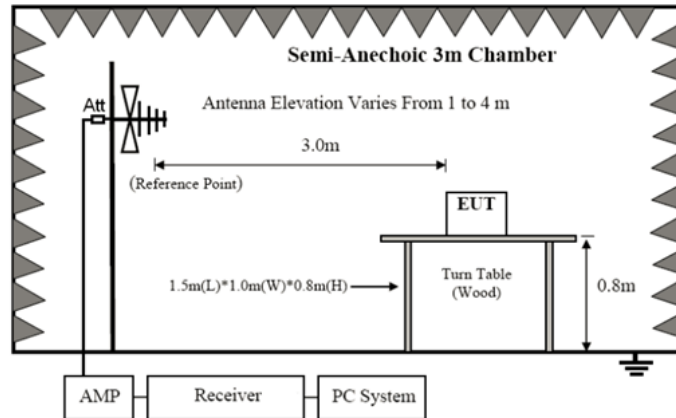

FCC Part 15C Class B 1GHz-18GHz -2



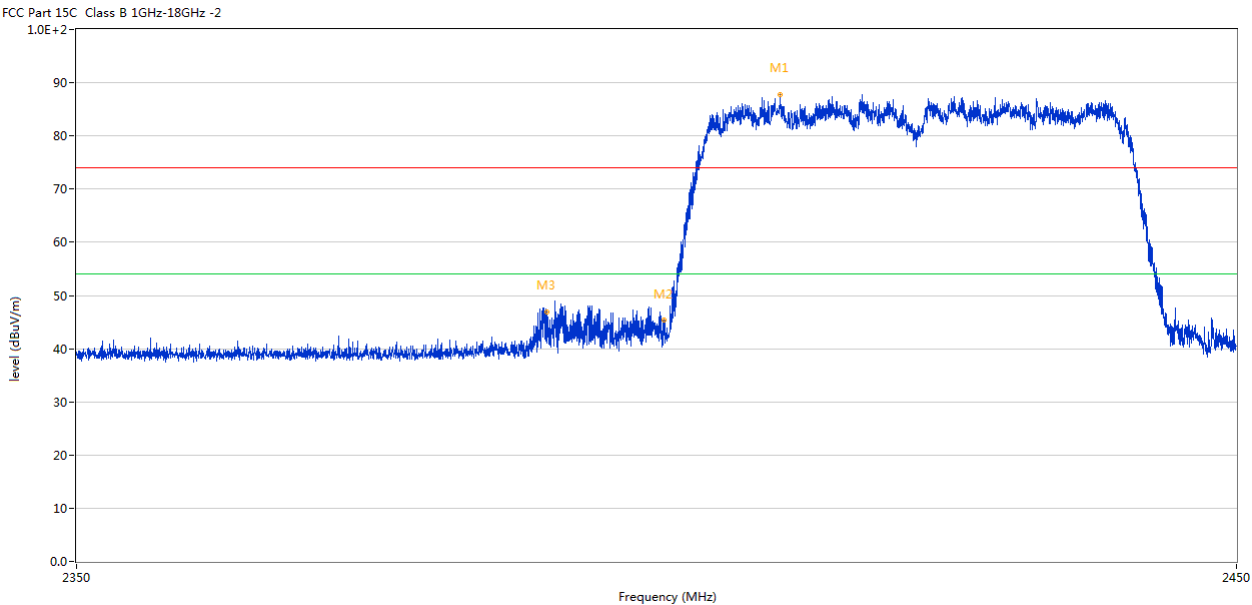

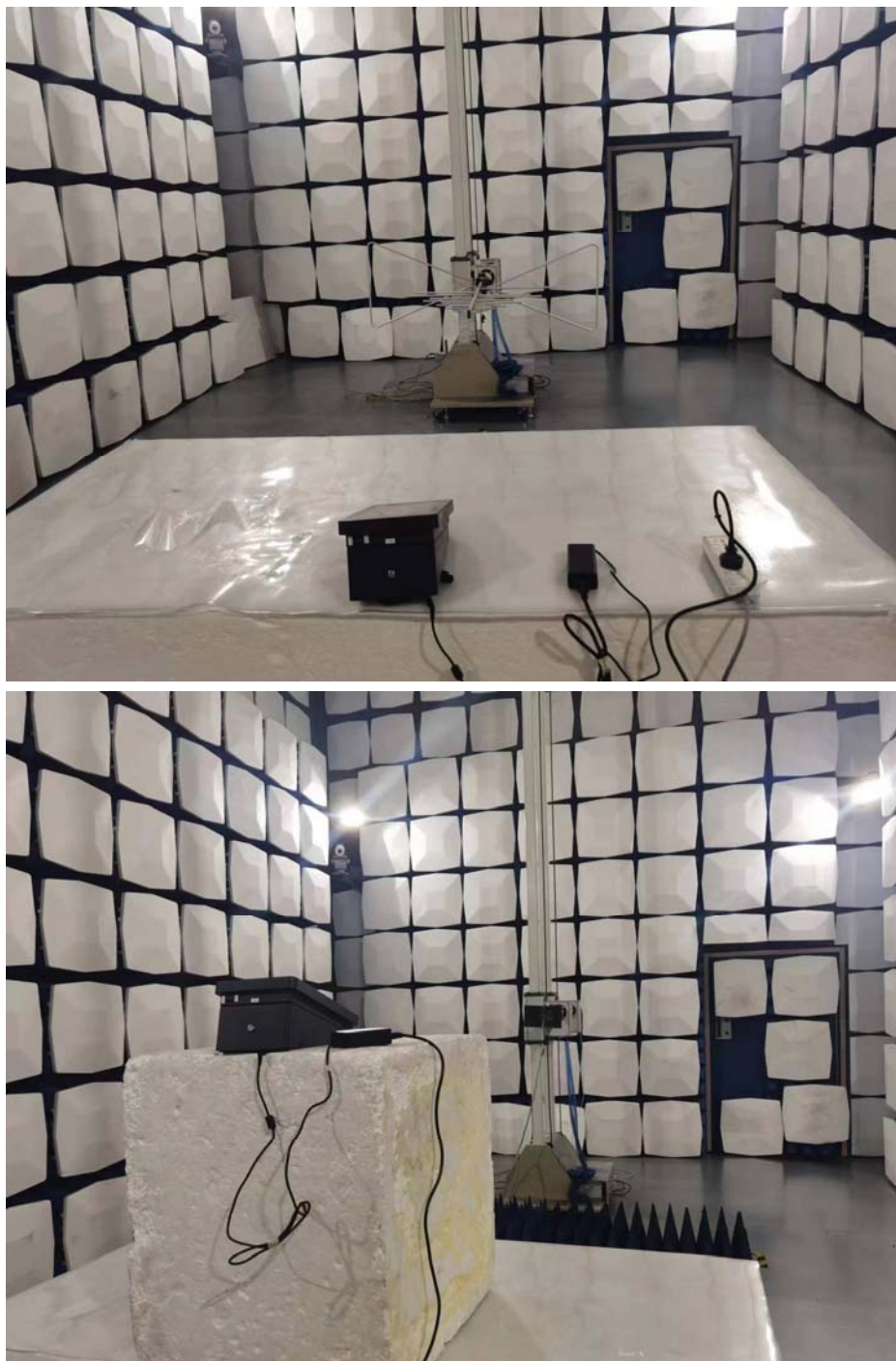
