


To get started with your watch you need to pair it with your phone.

## **Battery replacement**

Your watch has a replaceable battery with a lifetime of around 2 years, depending on usage. When the battery is running low, you will receive a notification on your phone, reminding you to hand in your watch for a battery replacement. Please visit only official stores to ensure that your watch stays water resistant after the replacement.

## **Important information**

Handle this device with care. Do not disassemble the watch, there are no serviceable parts inside the watch. It is important to keep small children away from it, as small parts may detach and pose a choking hazard. If you intend to use this transmitting device near sensitive medical equipment, we strongly advise you to request permission beforehand. If you have electronic medical implants, we recommend that you consult with medical experts before using this device to ensure that it is safe for you to do so. This product is not a medical device and should not be used to diagnose or treat medical conditions.

## **Batteries - WARNING**

This watch uses a lithium battery. Do not remove or replace the battery. Risk of fire and burns. Do not disassemble, heat above 55°C or incinerate. Keep battery out of reach of children. Never put batteries in mouth. Swallowing may lead to serious injury or death. If ingested, immediately seek medical attention.

## Radio frequency exposure

Your Lotus Connected device is equipped with a radio transmitter and receiver of Bluetooth™ Low Energy type, operating in the frequency range 2400 to 2500 MHz. Its radiated output power is far below exposure limits set by national authorities such as the FCC, European Council and international health agencies.
