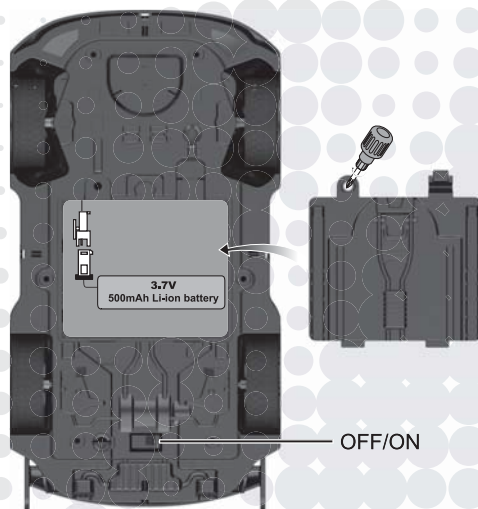

## 2.4GHz LED RC truck

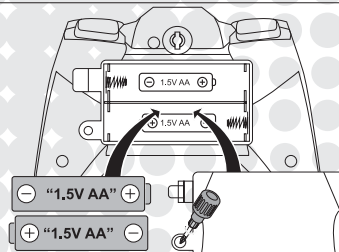
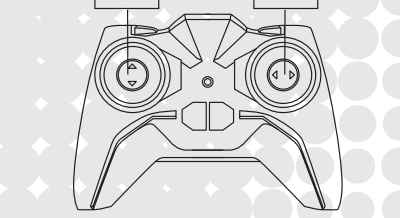
## Battery Installation



Car: 3.7V 500mAh Li-ion battery (included)

## Transmitter instructions

Backward Turn left  
Forward Turn right



Controller: 2X1.5V AA batteries (not included)



## How to charge the car battery pack:

Connect the 3.7V rechargeable battery pack to the USB charger, and connect the USB charger to an adaptor with USB charging port.

When charging, the red light will be on, when the charging is finished, the red light will be off.

## Safety Precautions:

- Do not operate during thunderstorms or rain.
- Avoid water, sand and snow when operating your car.
- Do not submerge car or controller in water.
- Never operate your car on the street or highway.
- Adult supervision is recommended when operating this car.
- Remove all batteries when not in use to avoid accidental operation.
- Never operate your car in a confined or crowded area and do not use people or animals as obstacles.
- Do not run your car into furniture, objects or hard surfaces, as this will cause damage to both the objects and the car.
- Keep fingers, hair and loose clothing away from the tires, gears and motor while the car is switched to "ON".
- Do not leave car or transmitter near sources of heat or under direct sunlight for long periods of time.
- Do not leave car or transmitter outside overnight.
- Dampness is harmful to interior components.

## Battery warnings:

1. Non-rechargeable batteries are not to be recharged.
2. Rechargeable batteries are only to be charged under adult supervision.
3. Different types of batteries or new and used batteries are not to be mixed.
4. Batteries are to be inserted with the correct polarity (+ and -).
5. Exhausted batteries are to be removed from the toy.
6. The supply terminals are not to be short-circuited.

The toy is only to be connected to Class II equipment bearing the symbol.
