






User Guide



Safety

How to use


1. Power button:
Press the button for 3 seconds to turn on the device, press for 3 seconds again to turn off the device.
2. Pause:
The device will be paused after working for 10 minutes, under any modes.
3. Working modes:
Press the button to switch to different modes. Low-heating mode is suitable for face massage. Medium and High-heating mode is suitable for body massage. Please test the temperature before using directly on your face.
 - 3.1) "Low-heating + Vibration", power button lights up with blue. Red indicator light stays on. Heating temperature: 40 °C.
 - 3.2) "Medium-heating + Vibration", power button lights up with green. Red indicator light stays on. Heating temperature: 45 °C.
 - 3.3) "High-heating + Vibration", power button lights up with red. Red indicator light stays on. Heating temperature: 48 °C.
4. Low power reminder:
If the device is out of power, it will shut down after the indicator flashing with red lights.
5. Charging:
USB charging. The device cannot be run while charging. The indicator will show in red while charging and turns to green when it is fully charged.

* Use the massage plate together with different modes for shape lifting, or simply massage with terahertz beads roller.

Usage area

1. Slide from forehead to ear area
2. Slide from nose wing top ear area
3. Slide from ear area to collarbone area
4. Slide from the area behind the ear to collarbone area
5. Slide from chin to ear area, then slowly move along the neck line to collarbone area

*Repeat 3-4 times, drink water after massage.



Usage area

Slimming & lifting Massage

1. Face: Slowly slide upward to the cheek area, and gently apply with pressure. For skin firming and shape lifting.
2. Mouth: Spiral movement on both corners of mouth. Prevent drooping of mouth corner muscle.
3. Forehead: Move slowly on forehead from bottom to top, and from middle to right/left. Effectively firm, prevent and reduce wrinkles.

*Repeat 3-5 times.



Tips of Massage

Mouth Corner: Massage slowly around mouth corner, slide up and move from left to right, to reduce laugh lines and wrinkles.

Neck: Massage your neck upward to reduce neck lines.
