Safety Precautions

^ Please read and follow the safety precautions carefully before use. Improper operation might pose a risk to personal safety and property damage. Do not use the product for other purposes other than as directed.

[DANGER]

- 1. Do not use the product on the head, eye area, laryngeal prominence or area of chest and back area near to the heart.
- 2. Stop using the product immediately if you feel any discomfort, and consult your physician for guidance.
- 3. The product is not intended for use by persons:
 - a) Under 14 years old:
 - b) Pregnant, lactating and menstrual women;
 - c) Have reduced physical, sensory or mental capabilities;
 - d) Feeling unwell or undergoing medical treatment;
 - e) Have or are undergoing medical electronic equipment (eg, cardiac pacemaker, artificial heart-lung or implantable medical devices);

- f) Have or are undergoing wearable medical electronic device (eg, ECG scanner);
- g) Have chronic diseases, heart disease, cancer and tumor etc;
- h) Have low immunity caused by immunosuppressive diseases, or taking drugs of immunodepressants;
- i) Have hypersensitive skin, contact dermatitis or skin disease;
- j) Light sensitive or taking prescription medicine of isoflavones;
- k) Have undergone surgical operation, laser minimally invasive operation, cuticle removal on the treatment area for the last 3 months.

- 4. The electrode plate on the middle part of main unit will generate heating during working. Be careful to use the product if you are not sensitive to heat. Do not stay on the same treatment area for too long to avoid scald.
- 5. Do not treat the same area for too long when using BURN mode. Make sure the treatment head is in close contact with your skin and moves slowly to avoid scald.
- 6. Do not use the product while driving or while concentrating on work.
- 7. Do not disassemble, repair or modify this product. Improper handling might lead to fire, electric shock, injury or product malfunction. Unauthorized disassembly or modification may result in exclusion from the warranty.

[WARNING]

- 1. The product is for personal care only, not medical device. Do not use the product for other medical purposes.
- 2. Do not use the product in conjunction with other medical devices.
- 3. Do not rinse the product in water while using.
- 4. Remove metal jewelry (eg. necklaces, rings, watches, earrings) before using the product to avoid possible strong electric shock from contact between metal part of jewelry and electrode of the main unit.
- 5. Do not look at LED light for a long time to avoid eye injury.
- 6. Do not use the product on below area:
 - a) Area with plastic surgery;
 - b) Injured and not fully healed area like abrasion, scratch and scald;
 - c) Area of skin inflammation caused by abscess, rash and sunburn:
 - d) Area of erythema caused by itching or physical stimulation;
 - e) Area with implanted metal, silicone, introducer in body, face and mouth;
 - f) Area with tattoo or artistic make-up.
- 7. The product can be used by person aged from 14 years and above, and persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the product in a safe way and understand the hazards involved. Children shall not play with the product. Cleaning and user maintenance shall not be made by children without supervision.
- 8. Do not remove the built-in rechargeable battery. Do not charge or use the product with high temperature. Follow local government laws and regulations for proper disposal of battery. Please recycle battery if possible. Do not heat battery or device containing battery into fire.
- 9. The product should be charged with an approved safety isolation adapter with the output capacity of DC 5.0V/2.0A and complied with IEC/EN 60335-1.

- 10. Make sure your hands are dry before touching the plug of USB charging cable or power adapter to avoid electric shock.

How to Use

1. Functional Modes

2. Operation Instructions

1) Power on: Long press on "Power" button around 1 second to start the device with two beeps. Power indicator, SLIM indicator and intensity

- indicator are on respectively at this time, it enters into SLIM mode with low level, LED light is red on treatment panel.
- 2) Power off: Long press on "Power" button around 1 second to turn off the device with two beeps. All indicators are off.
- 3) LED colour adjustment: Short press on "Power" button under any operating state, LED colour will be adjusted in a cycle of <Red-Blue-Purple-Off>. Switch of modes or levels will not change the LED colour.
- 4) Mode switch: Short press on "BURN" button BURN mode with low level; Short press on "SLIM" button when in BURN mode, SLIM indicator is on, and it enters into SLIM mode with low level.
- mode, or short press on "BURN" button when in SLIM when in SLIM when in SLIM when in BURN mode, intensity level will be adjusted in a cycle from <Low-Mid-High> with corresponding red intensity indicator turned on. Each time the mode is switched, intensity will be reset to low level.
- 6) Timer function: For any type of mode, the device will shut down automatically with two beeps after working for 10 minutes. Countdown timing will restart if you switch mode, while it is not workable for intensity level adjustment.


3. Charging Instructions

- 1) Power adapter is not provided. Please charge the main unit with an adapter of DC 5V/2A.
- 2) Charge the main unit at room temperature.
- 3) When the battery is low, the indicator flashes with 5 beep tones before power off. Please charge in time for normal use.
- 4) Charge the main unit with supplied USB Type-C cable. Logo indicator lights on with a breathing light during charging and stays on after fully charged.
- 5) Unplug power adapter and remove USB charging cable after fully charged. Constantly doing a full recharge will shorten battery's lifespan.
- 6) The product cannot operate during charging.
- 7) The product does not support Type-C quick charge.

4. Treatment Method

- 1) Precautions for use
 - a) Cleanse the treatment area before treatment, make sure skin is clean;
 - b) Apply adequate amount of skin care products such as gels, toners, and slimming lotions to the treatment area; try to use less skin care product that contains much oil to avoid influence on ultrasonic performance;
 - c) Start from low intensity level for initial use;
 - d) Do not stay on the same treatment area for a long time to avoid scald;
 - e) Do not use the product in bathtub or hot spring with body wash, or in hot sauna with high temperature;
 - f) Electrode head of main unit shall be in contact with skin as vertically as possible and move slowly. Do not press or rub hard.

2) Body care method (recommend)



Move as indicated arrow (refer to picture) during treatment.

♦ Waist and abdomen

Move from back waist towards navel, or move slowly around navel in a circle way.

Recommend mode: SLIM mode + red LED

BURN mode + purple LED

Frequency of use: Recommend 10 minutes per

time, 2-3 times per week.

♦ Thigh


Move from above the knee towards base of the thigh.

Recommend mode: SLIM mode + red LED

BURN mode + purple LED

Frequency of use: Recommend 10 minutes per

time, 2-3 times per week.



♦ Upper arm

Move from elbow towards underarm. Recommend mode: SLIM mode + blue LED Frequency of use: Recommend 5 minutes per time, 2-3 times per week.

♦ Hip

Move from lower part of hip towards outside. Recommend mode: SLIM mode + red LED BURN mode + purple LED

Frequency of use: Recommend 10 minutes per time, 2-3 times per week.

♦ Calf

Move from heel towards the back of knee. Recommend mode: SLIM mode + red LED Frequency of use: Recommend 5 minutes per time, 2-3 times per week.

Notes: Do not use the product on laryngeal prominence or area of chest and back right next to heart.

3) Please apply an appropriate amount of skin care product for moisture based on personal needs after treatment.

Cleaning, Maintenance and Storage

- 1. Switch off the product before cleaning.
- 2. Do not cleanse main unit with steel wire ball, alkaline detergent, abrasive chemicals, diluent, gas, nail polish remover or other corrosive liquids.
- 3. Clean the residue of cosmetics on treatment panel in time after treatment. Use a soft and wet cloth, wet tissue or cleaning cloth to wipe stains on treatment panel and surface of main unit. Wipe the treatment panel with dry cloth or tissue.
- 4. Do not immerse the product directly in water while cleaning.
- 5. Dry the product in a cool and ventilated place after cleaning, then store it in storage bag.
- 6. Do not keep the product in a place with high temperature or high humidity.
- 7. Charge the product every two months for not long-term use.
- 8. Do not put the product on uneven surface or high places to avoid injury from falling or damage to device itself.
- 9. Keep the product out of reach of children.
