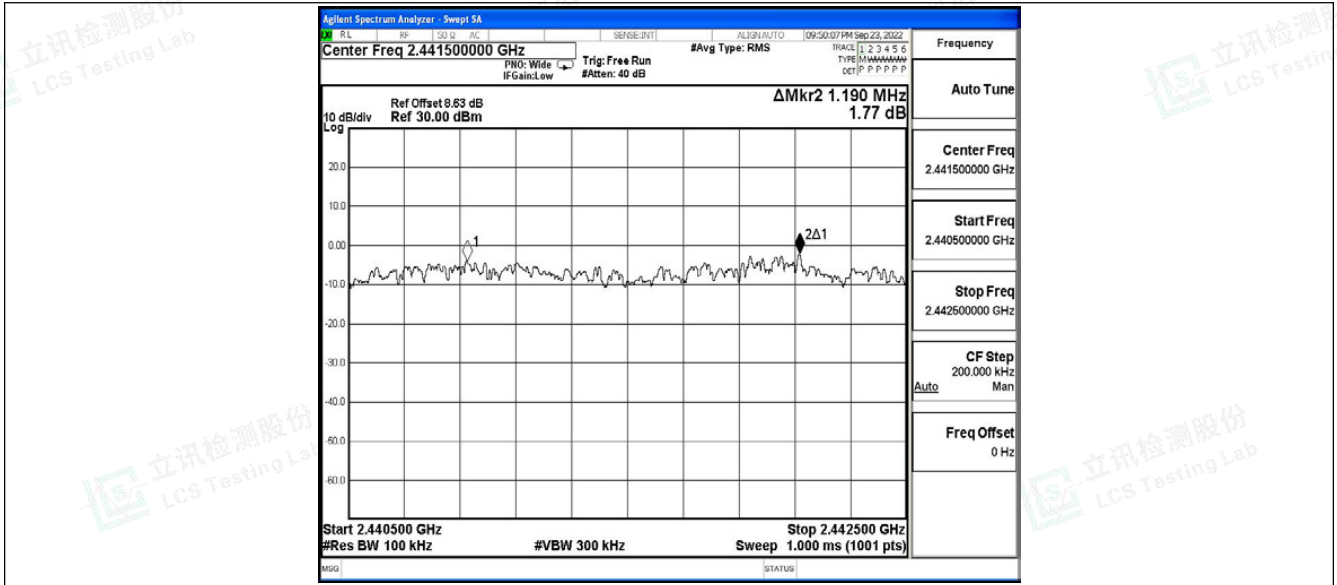

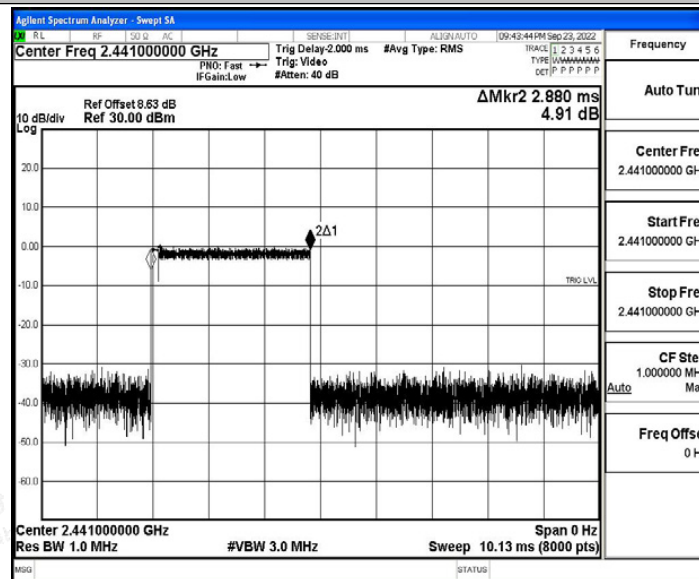

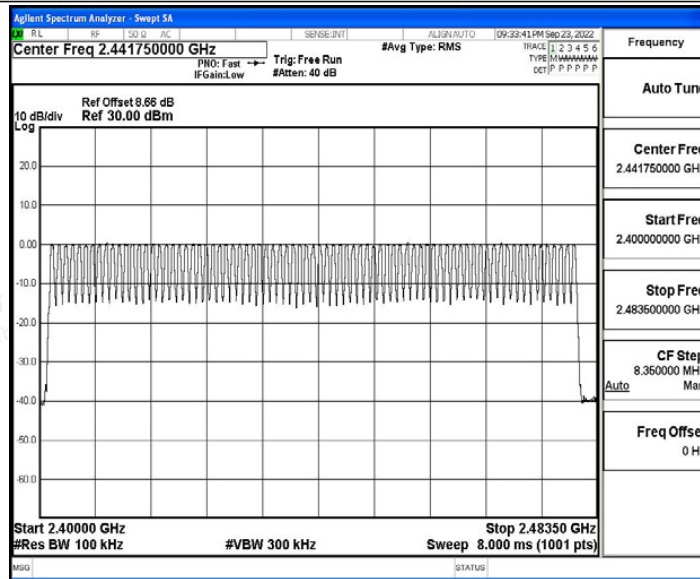

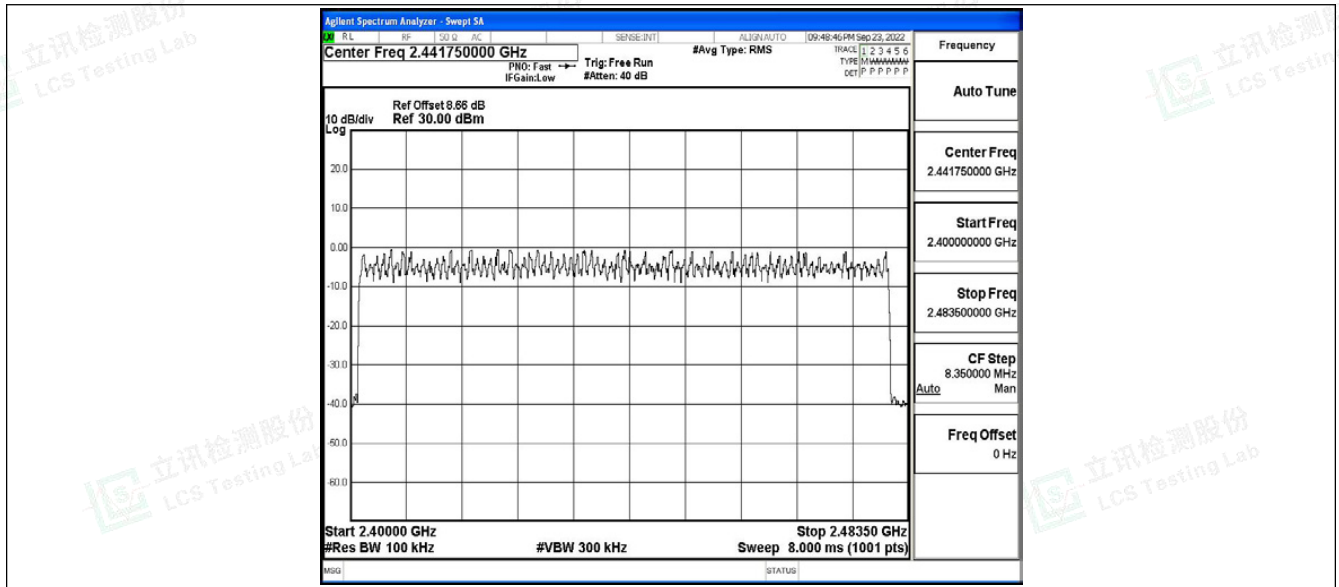

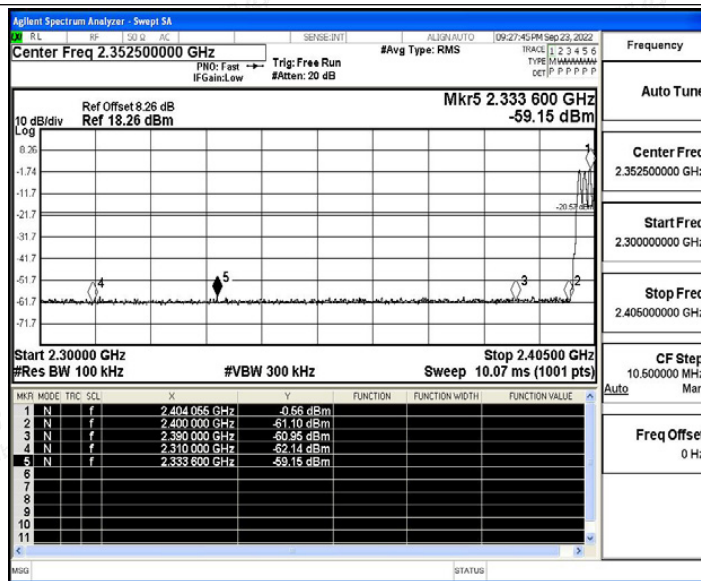


DH5_Ant1_High_2480

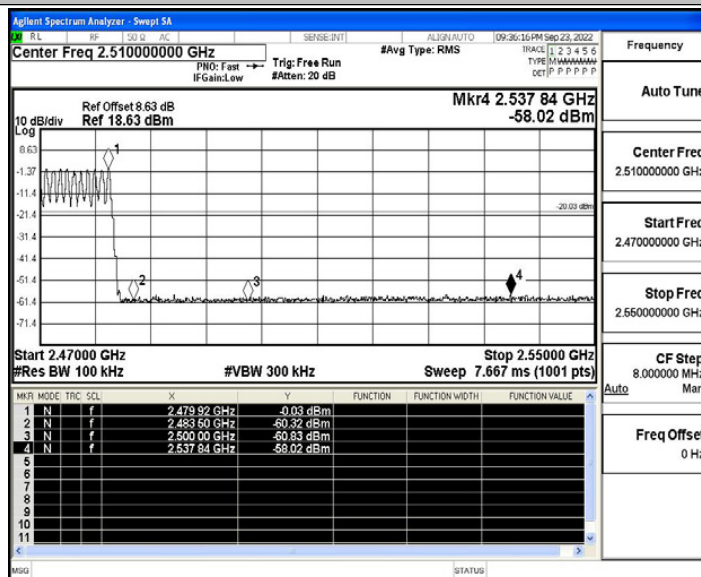


DH5_Ant1_Low_Hop_2402

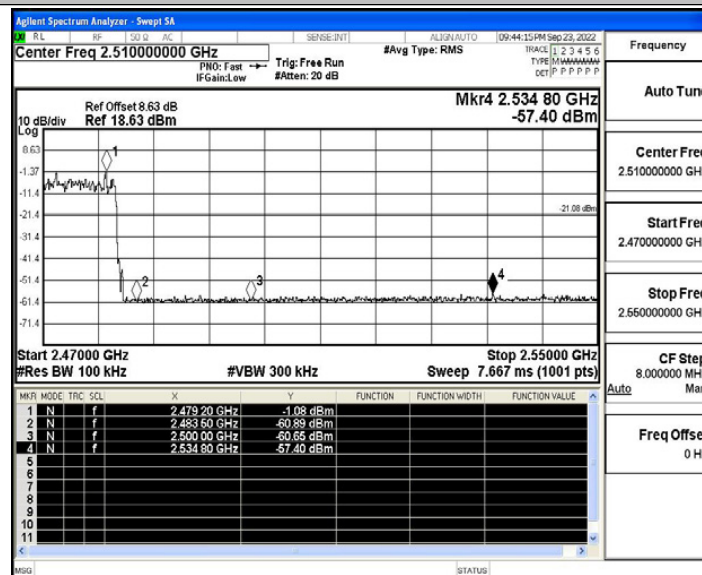


2DH5_Ant1_Low_Hop_2402



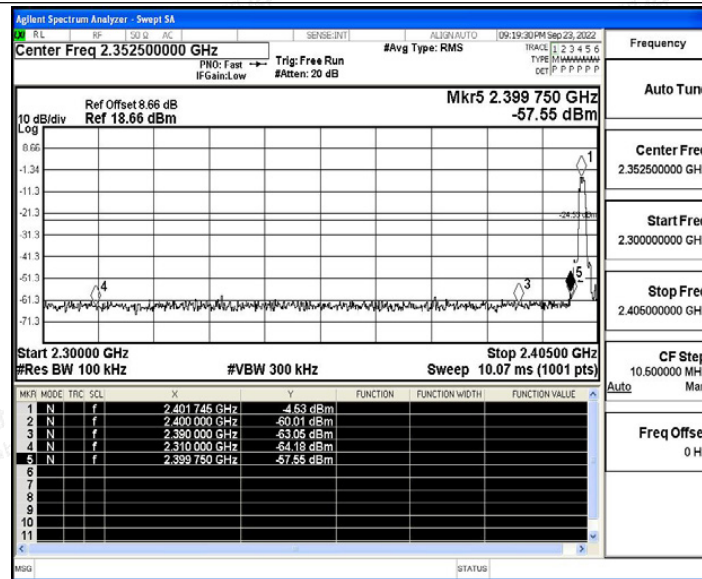

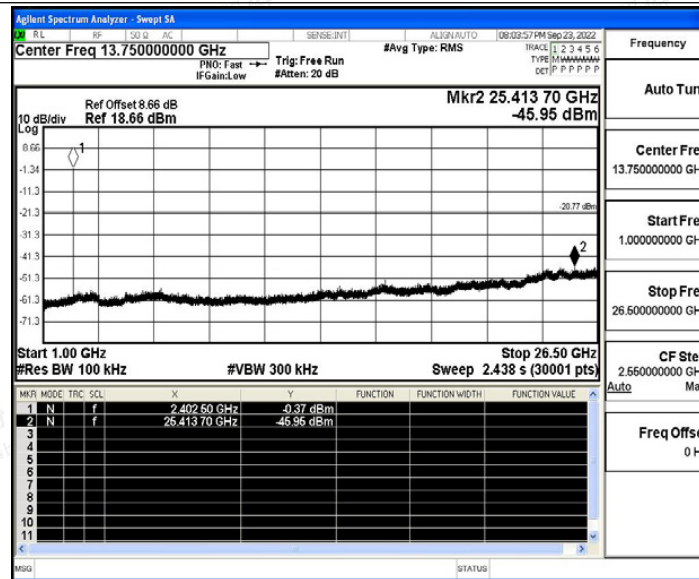


DH5_Ant1_2402_30~1000

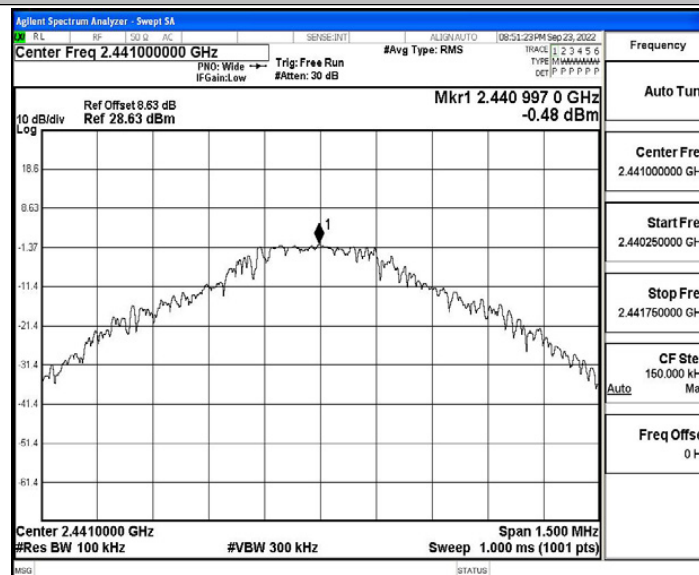


DH5_Ant1_2402_1000~26500



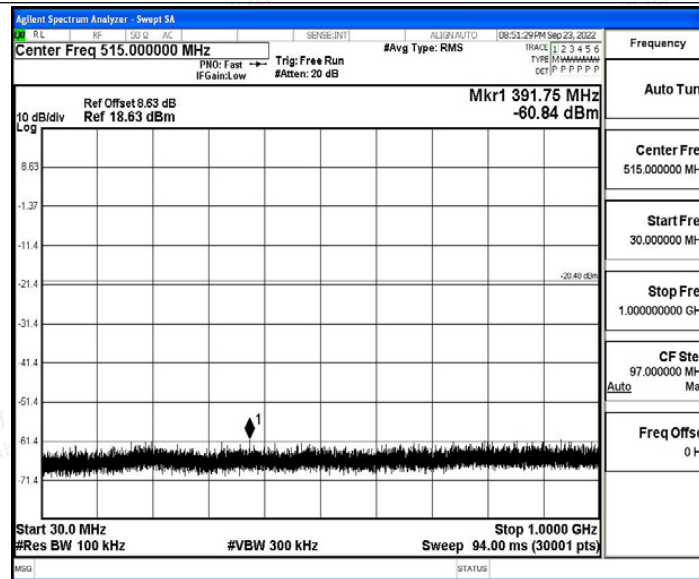

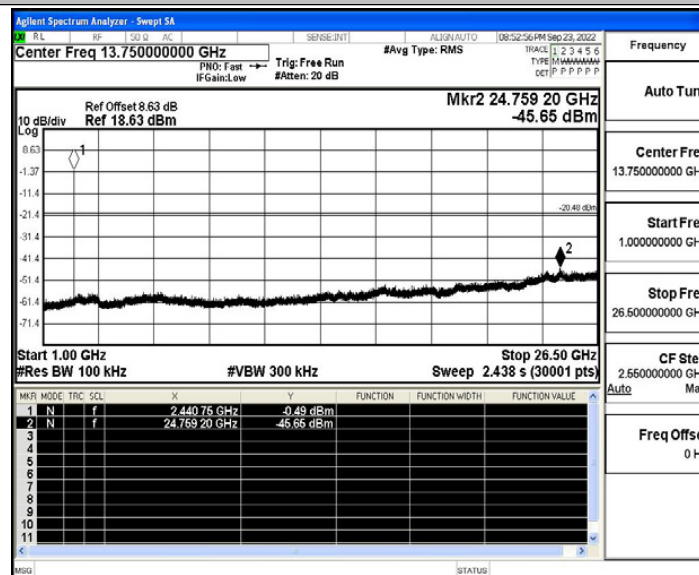
