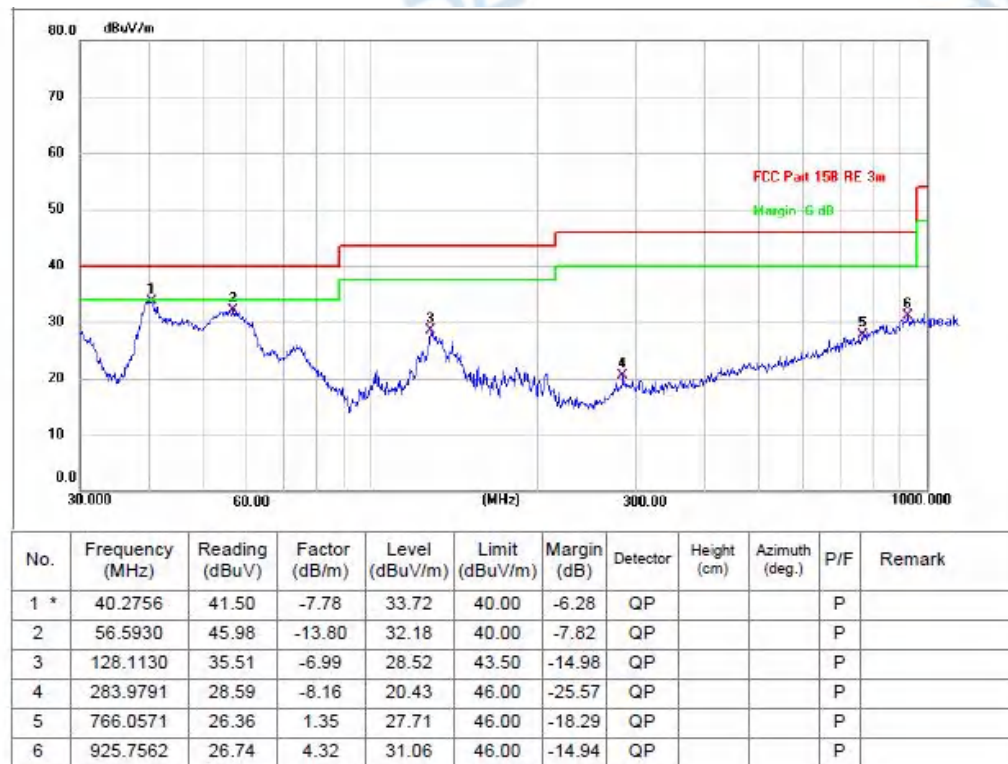

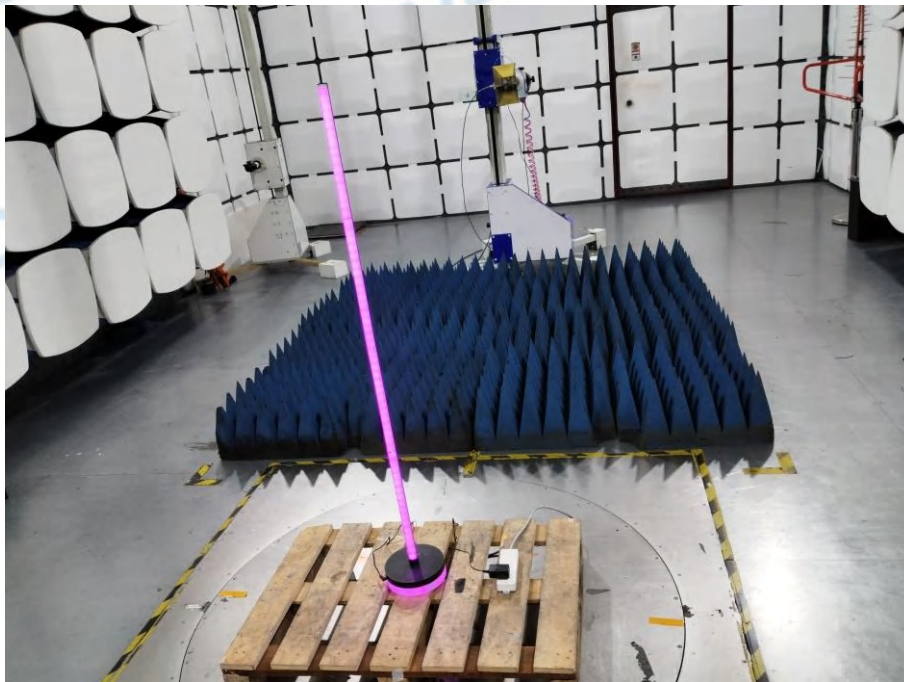


Emissions in frequency bands (below 1GHz)



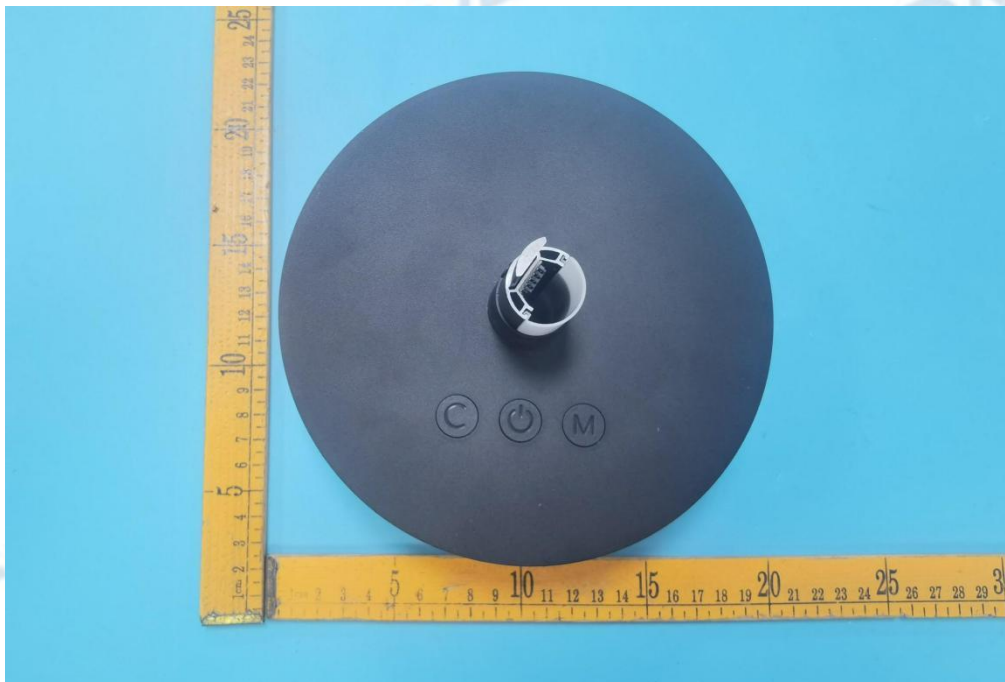


**Emissions in frequency bands (Above 1GHz)**



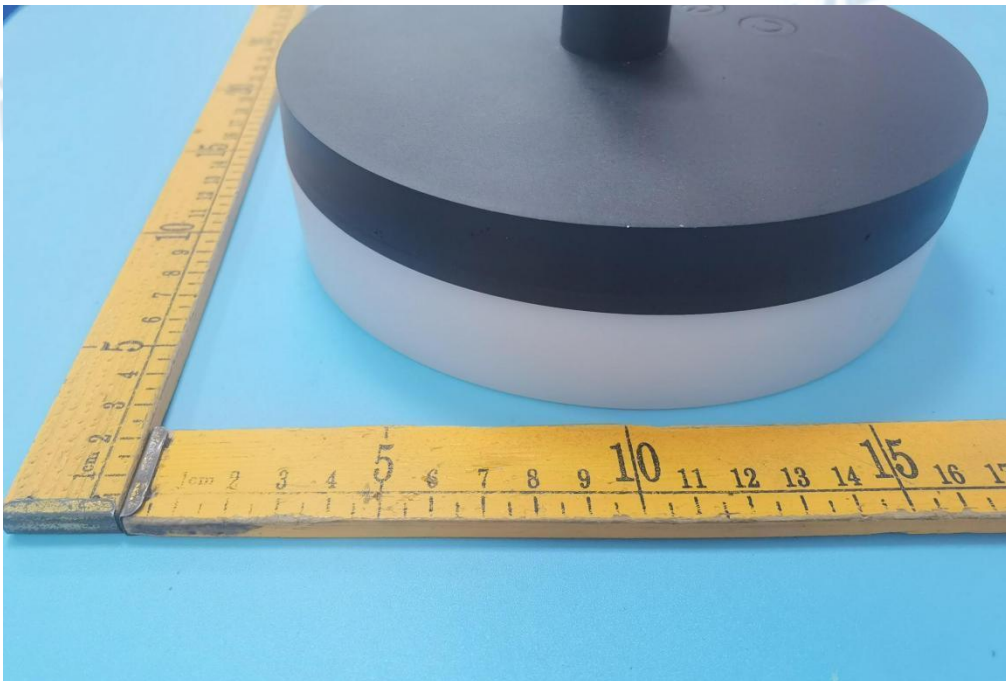
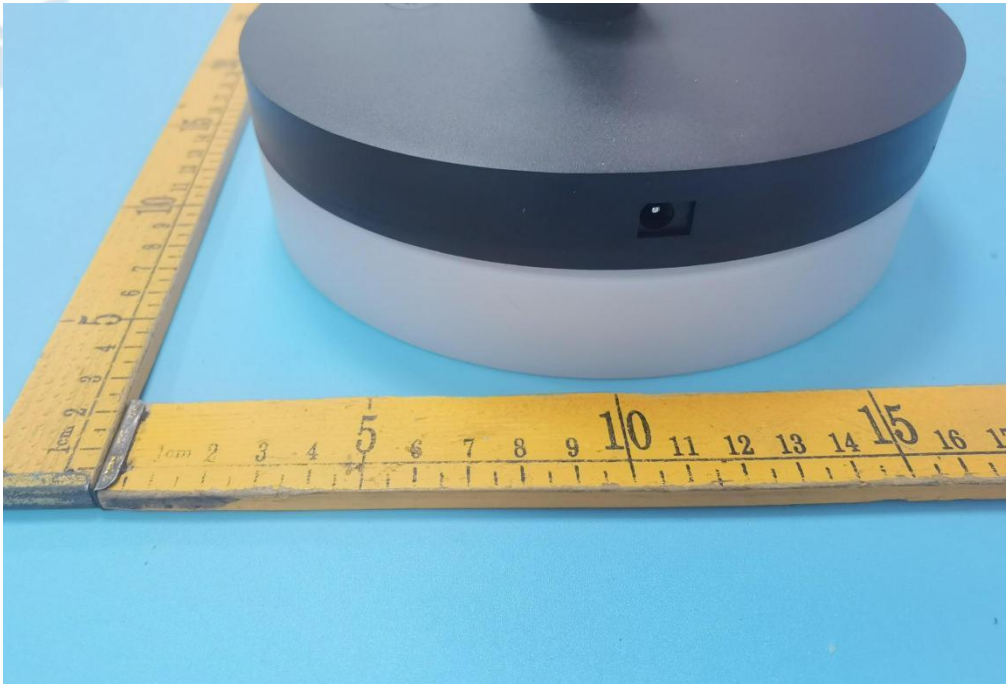
