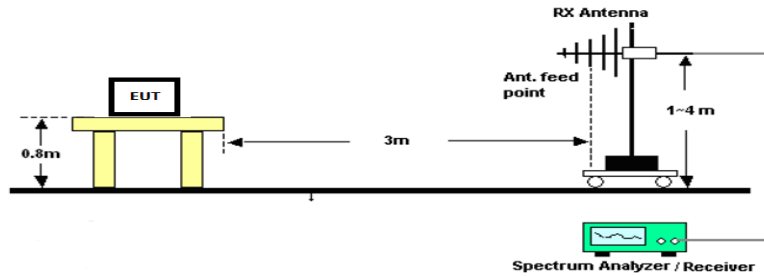

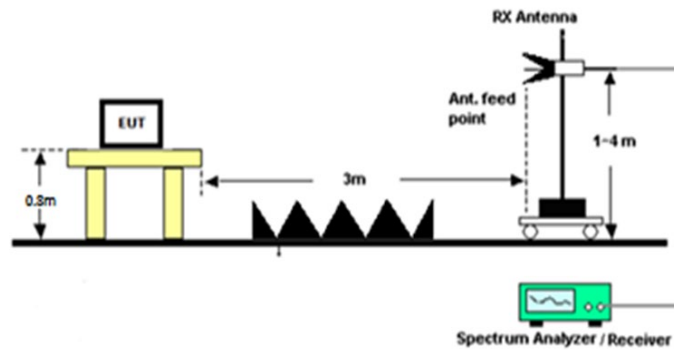

Radiated Test Setup, 30 – 1000 MHz

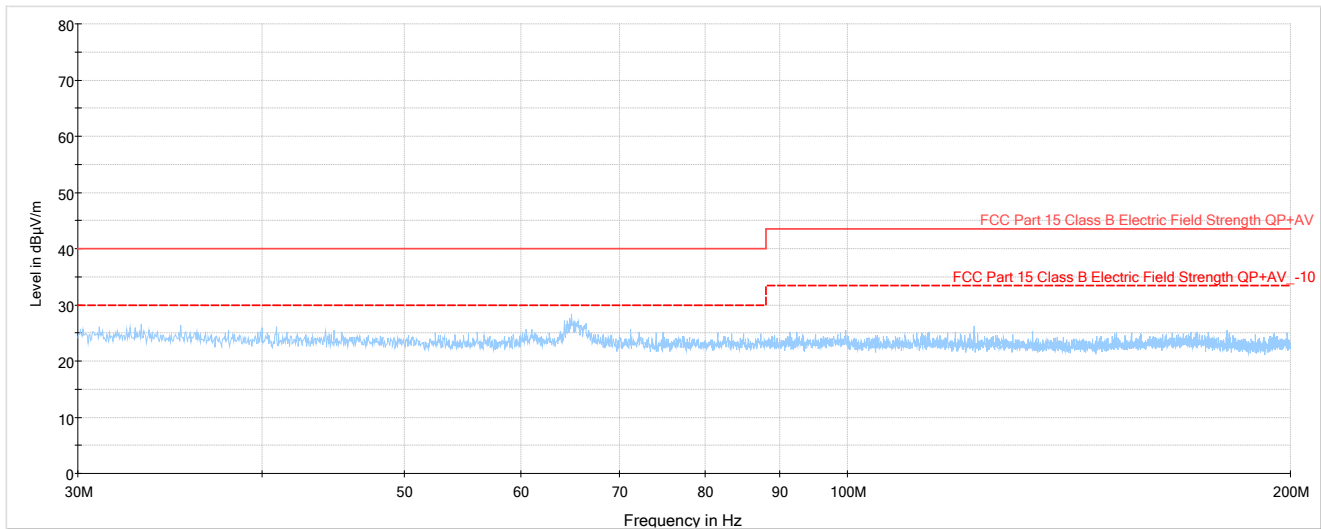


Radiated Test Setup, Above 1000 MHz

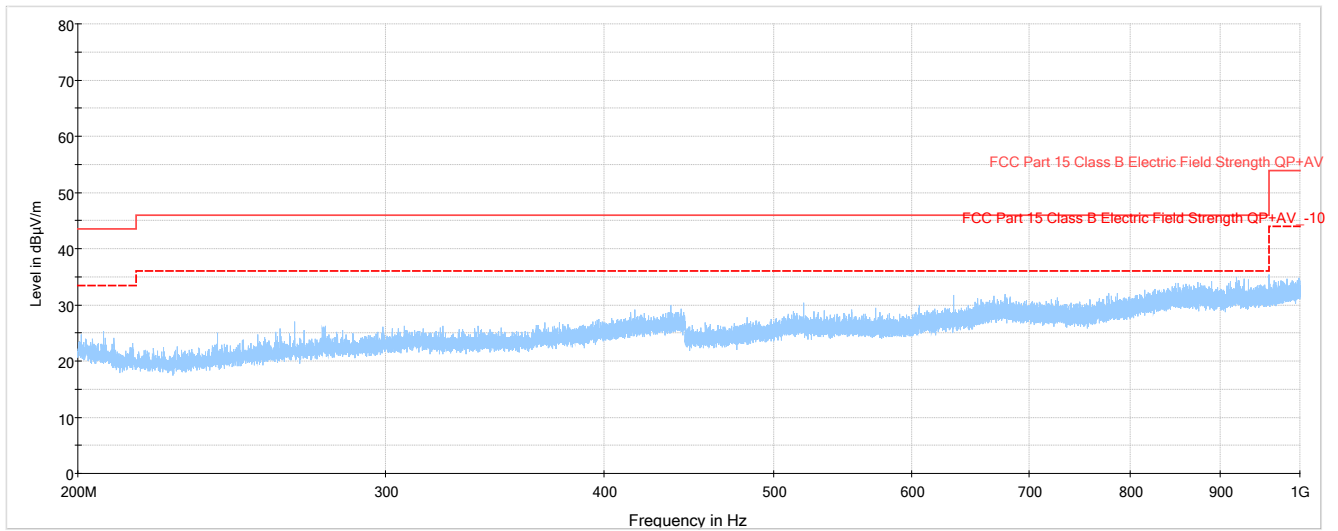

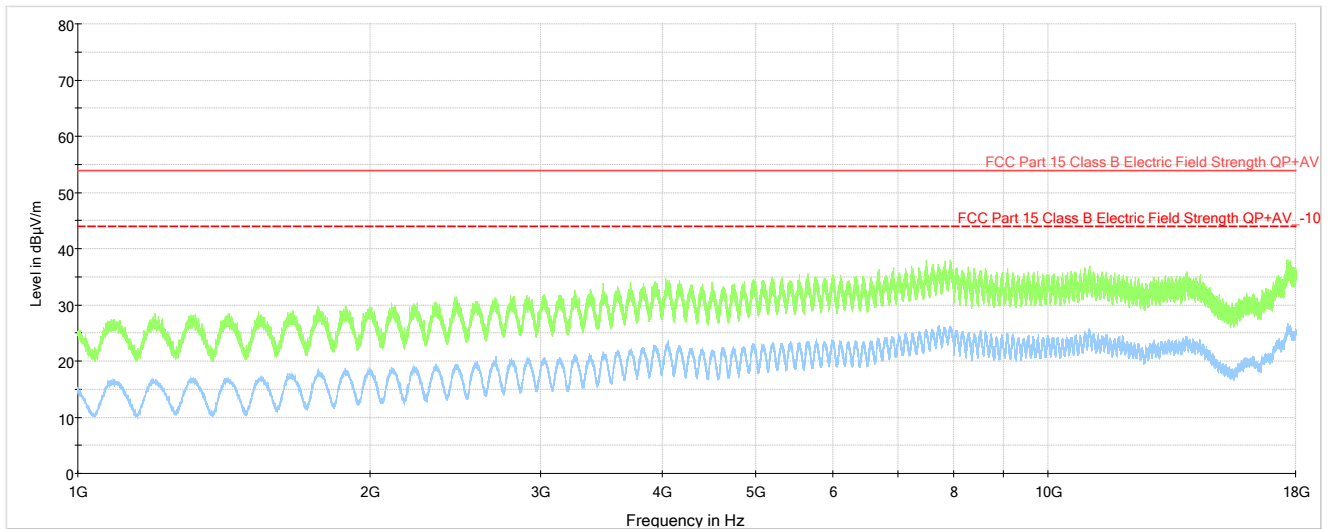

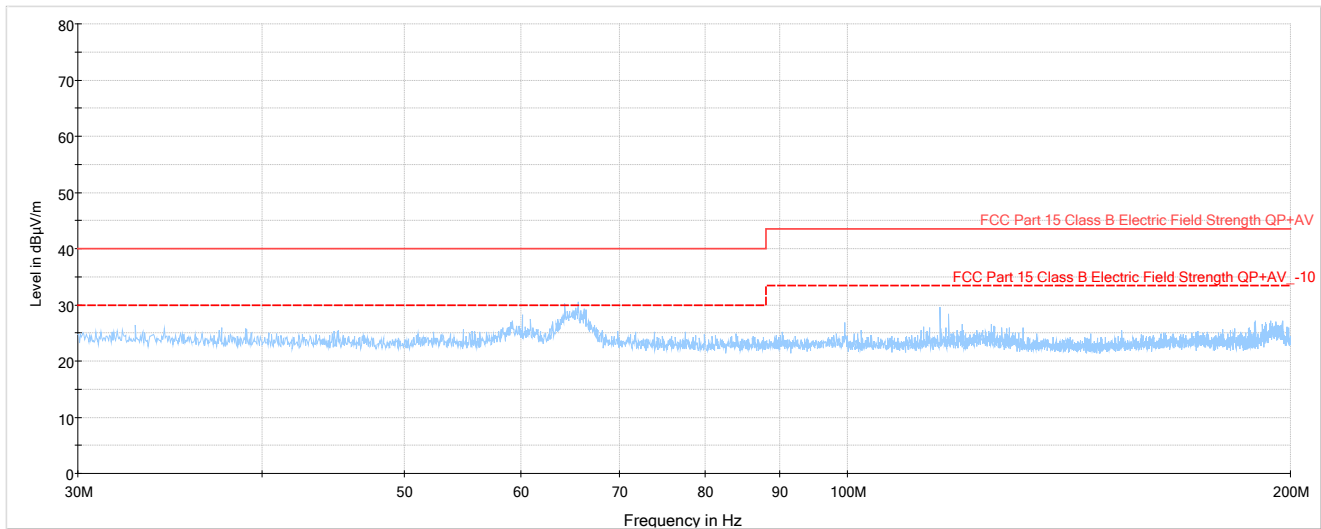

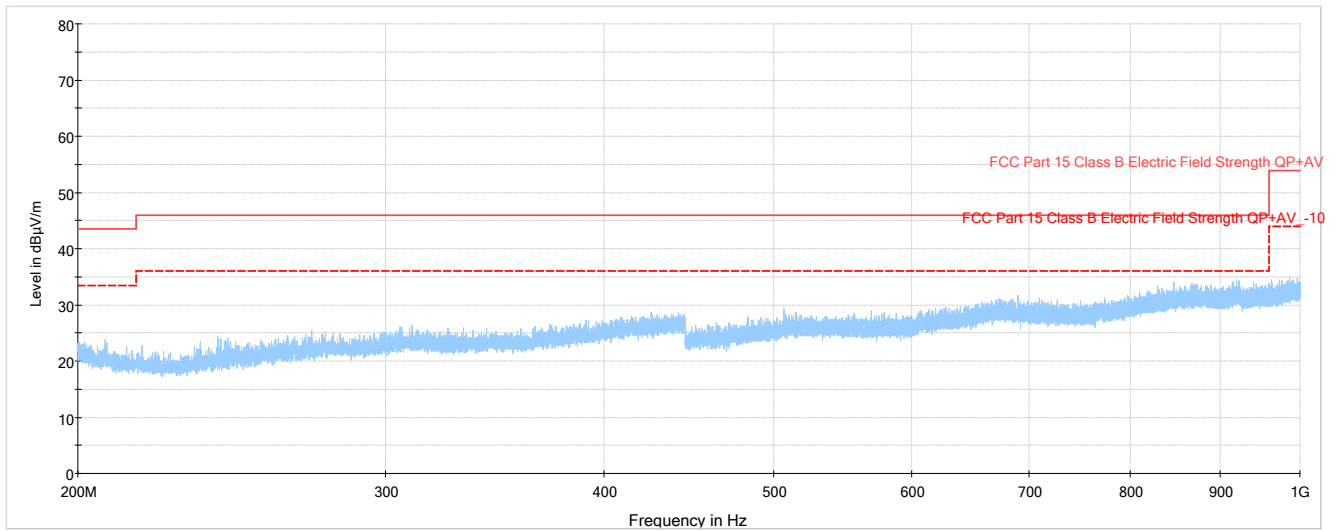

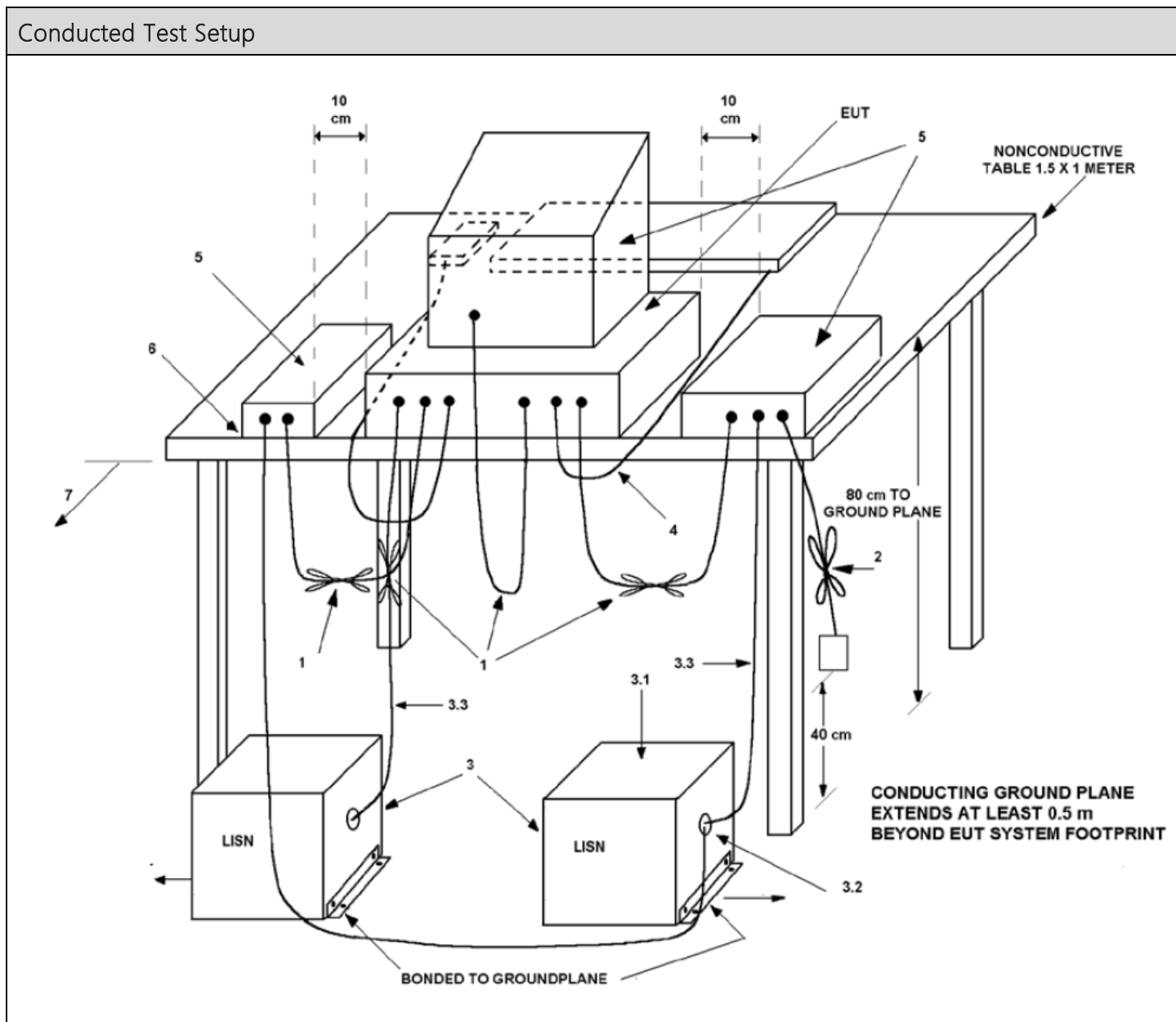

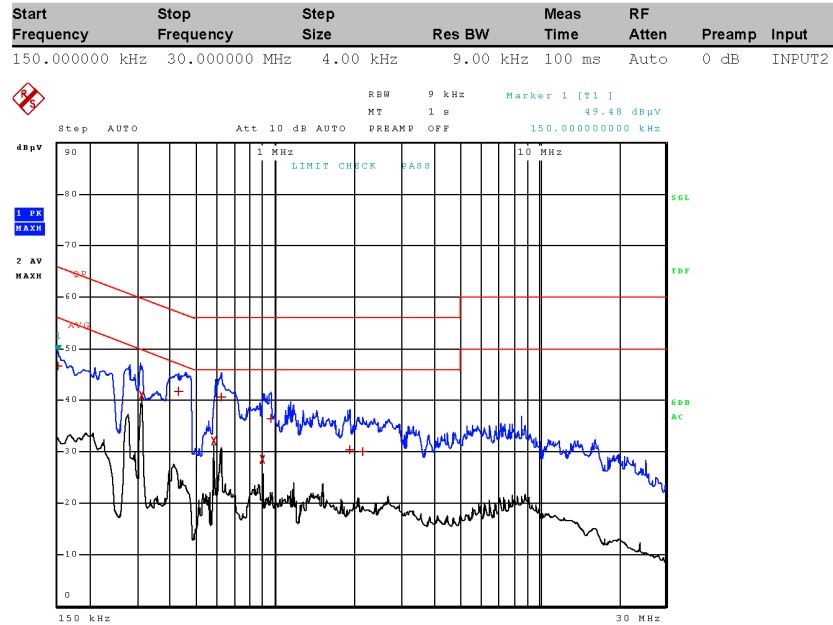
