You will hear "di di di".</div></div></div></div>

<div><div>CHARGING THE SPEAKER</div><div><div>- Plug the charging cable into the charging port of the speaker. Plug the USB into a compatible power source</div><div>- The red LED will turn on and indicate if the speaker is charging.</div><div>- Once the speaker is fully charged, the red LED will turn off. When the device indicates the battery is low, approx.4-5 hours of charging time is needed to fully recharge the battery.</div></div></div> <div><div>SAFETY INFORMATION</div><div><div>- Do not attempt to disassemble the device.</div><div>- Do not expose the device to extreme heat or flames.</div><div>- The speaker may become warm while charging. This is normal.</div><div>- Ensure all cable connections are removed and port cap is closed and tightly sealed before getting the speaker near water.</div><div>- Do not expose the speaker to water while it is charging.
