

# AST-ST001 User manual

## 一、Product overview

## 二、Product name: Air tag AST-ST001



## 二、Product pairing instructions

1. Open the "Find my" app (an app that comes with the Apple phone system, no need to download)
2. Click on 'Item', then click on 'Add Item';
3. Select 'Add Other Items' and a pairing pop-up will appear, displaying the device name is ' ST001 '
4. Click on 'Connect', then name the item and select an emoji
5. Click 'Continue', the product has completed the connection

## 三、Product Function Description

6. Power on: Press and hold the button for 3 seconds, make a beep sound, and turn on the device;(In order to check if the product is turned on, double-click the button, beep once, indicating that the device has been turned on)
7. Shut down: Press the button 5 times continuously within 2 seconds, the product will emit a brief ringtone and shut down;

## 8. Restore factory settings:

- After the product is turned on, double-click the device button and make a beep sound;
- Immediately press and hold the button for 3 seconds to make a beep sound;
- Do not release the button, continue to hold the button for about 1 second, and the product will emit a brief ringtone again, Release the button and the factory reset is complete.(Once the factory reset is completed, The tag will in power on state, which can be paired)

## 四、APP Function Description

1. Play sound: If an item is left nearby, you can search for it by playing the ringtone;
2. Route: Locate the location information of your item, which will be displayed on the map with emoticons for item naming. You can also find the location information of the item through map navigation;
3. Share this item: You can share the item with others and view the item information, but the sharing objects will not receive notifications when this item is approached;
4. Lost notice: Set the location distance of the item, and the device will receive a message notification when it is lost;
5. Loss patterns:
  - ◆ If someone passes by with an iPhone near the lost product, the "Find my" app will receive notifications and location information of the lost product
  - ◆ Fill in your phone number and email information. When someone finds your product, your phone number and email information can be seen on the Apple website and you can be contacted;
6. Rename item: Change item name, emoticon;
7. Remove item: Remove product pairing;

8. Battery reminder: When your product's battery is low, it will trigger a battery reminder. It is recommended that you replace the battery to prevent it from being unable to connect to the product after the battery is depleted。

## 五、Product pairing problem explanation

### 1. Equipment status confirmation

- ◆ Double click the button twice, and the product will make a "beep" sound, indicating that the product has been paired;
- ◆ Double click the button twice, and the product will emit a "beep beep beep" sound, indicating that the product has been turned on and is not paired or connected;

2. Double click the button twice, and the product does not make any sound, indicating that the product is not turned on;

### 3. Pairing connection status

- Remove product pairing, the product emits a brief ringtone, and the removal is successful;(Remove product pairing, in power on state, can pair new devices)
- After turning on and removing the pairing, if there is no pairing within 10 minutes, the product will exit pairing mode and cannot connect to the device. You need to click the button once and make a "beep" sound to re-enter pairing mode.

## 六、Battery replacement instructions

- ◆ Battery model: CR2032 button battery;
- ◆ After replacing the battery with a new one while the product is in the shutdown state, the product remains in the shutdown state;
- ◆ After replacing the battery with a new one while the product is turned on, it remains in the powered on state.
