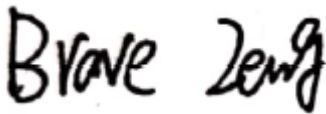

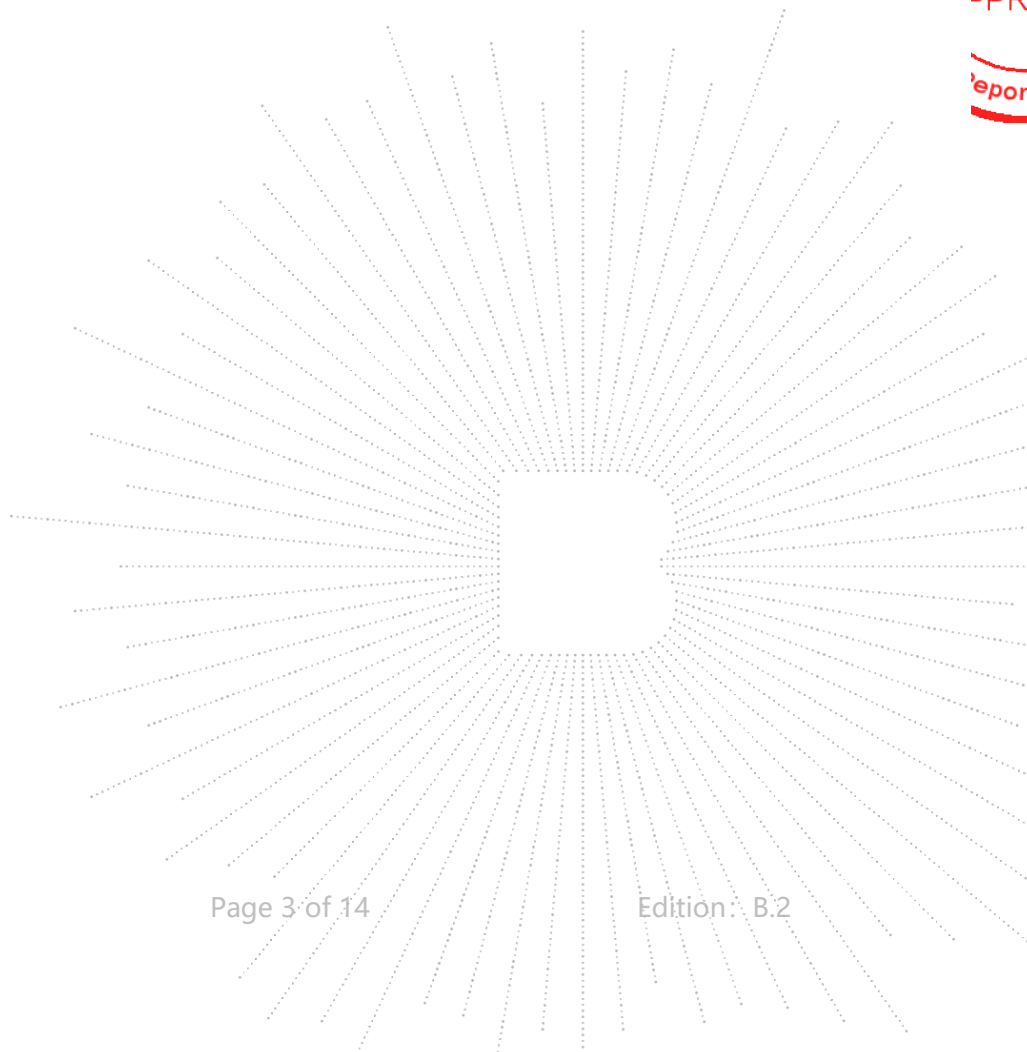

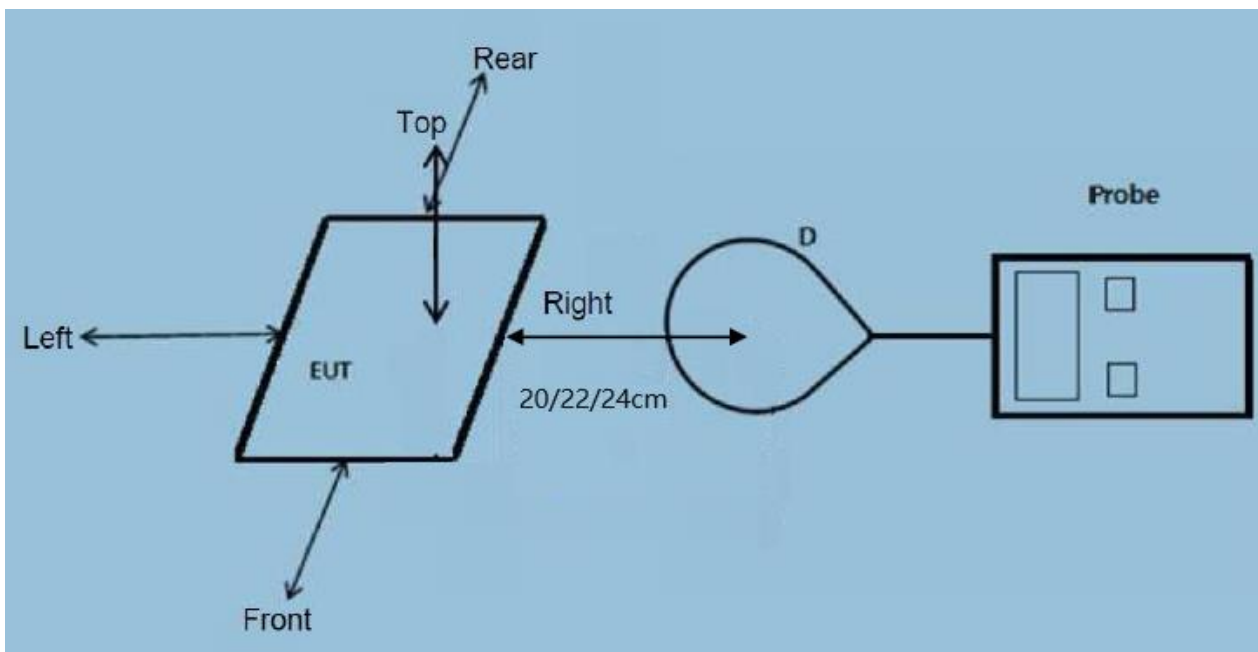

4.4 Test procedure

- The RF exposure test was performed on 360 degree turn table in anechoic chamber.
- The measurement probe was placed at test distance (20/22/24cm) which is between the edge of the charger and the geometric centre of probe.
- The turn table was rotated 360d degree to search of highest strength.
- The highest emission level was recorded and compared with limit as soon as measurement of each points (A, B, C, D, E) were completed.
- The EUT were measured according to the dictates of KDB 680106 D01 v04.

4.5 Equipment Approval Considerations

The EUT does comply with item 5.2 of KDB 680106 D01 v04

1) The power transfer frequency is below 1 MHz.

2) The output power from each transmitting element is less than or equal to 15 watts.

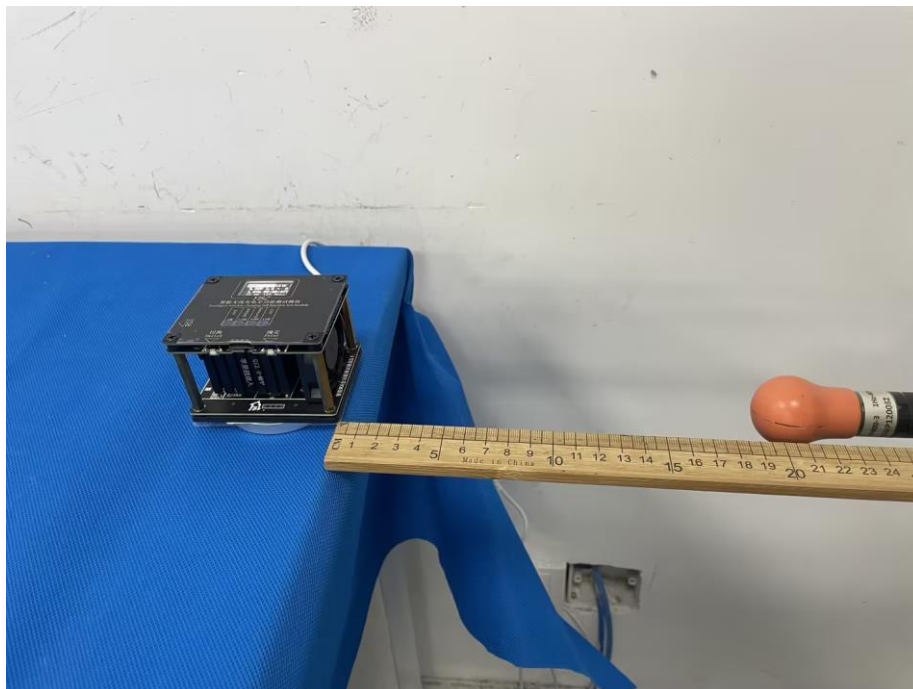
