Quick Start Guide

1. Power On/Off Instructions:

Press and hold the power button for 3 seconds to turn on the device. The power light will automatically turn off after 10 seconds. To turn the power light back on, tap the power button again. To turn the device off, simply press and hold the power button for 3 seconds.

2. Wear Instructions:

Clean the area. Apply the adhesive electrode pad under your chin, but above the throat. Point the rounded outward side of the pad up toward your chin, so that the indented side will point down toward your throat. Once applied, press and hold the pad so that it adheres strongly. Device attaches magnetically to the pad.

3. Bluetooth Connection and Data Syncing:

- Go to www.intellisnore.com/app to download the app
- Enable your phone's Bluetooth, open the app, and turn on the device.
- Follow the instructions on the app to pair the device.
- Tap the device's power button, so that the Bluetooth light will illuminate.
- Your data will now be synced to the app.

4. Adjusting Intensity:

If the out-of-the-box intensity of stimulation is too high, open the app and adjust your settings by tapping the gear in the upper righthand corner.

5. Unsuitable Users:

People with the following conditions: pacemakers, implantable defibrillators or any other implanted metal or electronic devices; acute suppurative inflammation, a tendency to bleed, or malignant tumors in the submandibular region; severe cardiovascular or cerebrovascular problems; ventilatory disorders caused by nasal disease; an allergy to electrodes or currents; skin ulcers on the site of adhesion; pregnant women or those in labor; and children under 16. Allergy Statement: This adhesive pads may contain traces of latex and/or silicone. If you have any known allergies to these components, or show signs of reaction for any reason, do not use this product or discontinue use immediately.
