Ii. Product components



Three, accurate use and wear guidance

The main machine of spray bark stopper uses lithium battery as power supply, and is equipped with USB charging cable, which can be recharged. Remove the worry of changing the battery.

The remote control of the spray bark stopper is powered by the button battery and can stand for about 30 days.

Indicator display mode:

1. When starting up, the green light flashes every 3 seconds, indicating that it is in automatic spray mode;
2. When starting up, the red light flashes every 3 seconds, indicating that it is in remote control mode;
3. If the traffic light blinks continuously, it indicates that the power is insufficient and needs to be charged.

Startup mode:



1. After holding down the on key, the red light flashes once to start the remote control mode. (Red light flashing every 3 seconds, normal working condition)
2. Press the on key again and the green light flashes once, then switch to automatic spray mode (the green light flashes once every 3 seconds, normal working state)



Off mode:

After holding down the on key for 3 seconds, the traffic light blinks at the same time, and the host mode is normally closed.



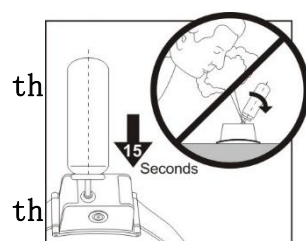
Remote control mode:

Hold down the remote control spray button, the main machine will trigger the spray, hold down the remote control switch, the main machine will stop the remote control function.



Charging mode:

When charging, please turn off the machine and connect the mobile phone charger and desktop computer with UBS data cable.



Replenishment of air and body fluid volume:
The machine must be shut down before replenishing

Gas, and then start the main engine.

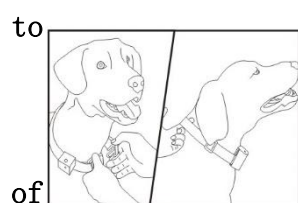
Aeration point: before aeration, put air into

the machine

Drain (with a small screwdriver to the pressure twice)

The filling tank is fixed vertically with the bark stopper

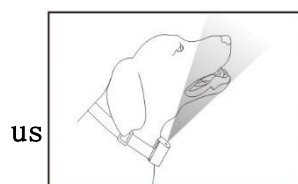
Press into the air vent and hold for 10 seconds

Iv. Product functions and effects

1. Low power consumption, lithium battery can be recharged repeatedly, without replacing the battery, reduce environmental pollution.
2. The remote control mode can manually stop the barking according to the state of the pet, and the effective remote control distance is 1-80 meters.
3. Spray bark stopper can effectively stop pets from barking. The vibration frequency generated when dogs bark will
The inductive reception system in the bark stopper is triggered and an air mist is emitted to warn the dog to stop barking.
4. Citronella spray, which is made of Citronella essential oil and does not contain CFC, belongs to ring
The product is safe and harmless to humans and dogs. (110g/bottle, 3 OZ)
5. The spray bark stopper can be worn on the dog in a short time, without long training.
6. The bark stopper has small volume and large air capacity. It can be sprayed 20 times after filling with gas.
8. When the dog barks, the spray stop will warn the dog. After being warned, the dog will distract its attention and stop barking to achieve its purpose, and the owner needs to praise and encourage the dog. After a short period of adaptation, the dog will remember the warning of the spray stop when barking.

5. Important tips

1. This product is suitable for large, medium and small dogs and shall not be used for any other dogs not described in this manual
The purpose of;
2. If the bark stopper is worn on the dog for a long time, it will cause a condition similar to mattress scar, that is, oppression
To reduce the possibility of skin necrosis, please refer to the following methods:

3. Check your dog's neck frequently for any rash or sore spots;
4. Supervise your dog for the first day or two after putting on a bark stopper;
5. Check the device in real time to prevent excessive pressure. It can be tolerated when the bark stopper is worn between the dog's neck and the next finger;
6. Scrub the area around the dog's neck and the bark stopper sensor on a weekly basis.
7. Do not attempt to remove or repair any parts of the product, as doing so will void the warranty;
8. If your dog shows extreme resistance to wearing a bark stopper or acts in a dangerous manner, the dog should be removed from the boot. If the boot is invalid, please stop using the product immediately.
9. We recommend this product for dogs 6 months of age weighing 8 pounds or more.
10. Bark stopper should not be used continuously for 12 hours within 24 hours.

6. Fault comparison table

Spray bark stopper not working	When the traffic light blinks continuously, it indicates insufficient power and needs to be charged.
	If the sprayer still cannot be sprayed, contact your local distributor
The dog did not respond to the spray	Reinforce the bark stopper and ensure that the sensor system is close to the dog's neck skin
	Check and make sure the spray nozzle is pointed at the dog's nose
	Make sure the dog hair doesn't interfere with the spray
