# Intended Use & Installation

The Halter collar is intended for use on a cow as part of the Halter system. Collars are to be used in accordance with Halter's Terms of Service or other executed customer agreement that you have in place with Halter or a certified distributor of Halter. The collars are to be fitted during onboarding to the Halter system, with support from a Halter Representative and/or Halter-certified third parties where required.

Save these instructions

- Halter technology should not replace mandatory human care and supervision of the animals.


