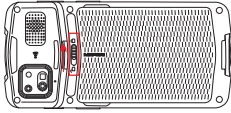
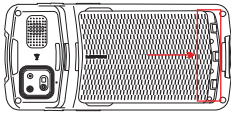
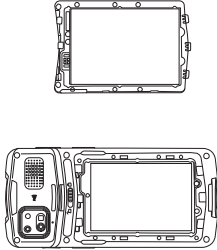
SIM Card Installing

Use the silver tab on the upper left corner to pull out the SIM card holder. Put the SIM card into the corresponding slot (as shown in the picture). Push the holder fully into.



Battery Installing

Align the battery into the battery compartment and press the battery firmly, then slide the rear cover lock to the right until it locks.



NOTE: Overexertion should be avoided when installing or removing the battery.

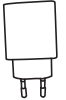
Instructions for Charging

Power Options

- Power on: Press and hold the power button until you see a splash on the device.
- Power off: Press and hold the power button until the pop-up reminder appears and then click "Power off".
- Forced restart: Press and hold the power button for 10 seconds. the power is on, and it can be activated immediately after pressing the power button.
- Fast start: The battery can be replaced within 5 minutes when the power is on, and it can be activated immediately after pressing the power button.
