<p>Test Procedure:</p>	<ol style="list-style-type: none"> 1. The EUT was placed on the top of a rotating table (0.8m for below 1G and 1.5m for above 1G) above the ground at a 3 meter camber. The table was rotated 360 degrees to determine the position of the highest radiation. 2. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower. 3. The antenna height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement. 4. If the emission level of the EUT in peak mode was 10dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.
